By its resolutions II/5 and III/3, the International Conference on Chemicals Management invited OECD, UNEP and the other Participating Organisations of the Inter-Organization Programme for the Sound Management of Chemicals (IOMC), as part of their mandate and work programme, together with governments and other stakeholders, to consider the development, facilitation and promotion in an open, transparent and inclusive manner of national and international stewardship programmes and regulatory approaches to reduce emissions and the content of relevant perfluorinated chemicals (PFCs) of concern in products and to work towards global elimination, where appropriate and technically feasible.

To enhance and further the implementation of resolutions II/5 and III/3, and to help facilitate the participation of all interested governments, NGOs and other stakeholders, especially those that are not from OECD member countries, OECD and UNEP set-up a Global PFC Group.

In order to support these efforts, the OECD/UNEP Global PFC Group is holding a series of webinars. This webinar is the second in a series and will provide insights and information that are available on uses of and scientific evidence relating to long-chain PFCs. This webinar will be followed by two additional webinars that will allow to go into more detail on two other topics: i) alternatives to long-chain PFCs and ii) regulatory approaches that are being implemented in several countries.
