### **DRAFT ANNOTATED AGENDA**

The revised draft *OECD Due Diligence Guidance for Responsible Supply Chains of Minerals from Conflict-Affected and High-Risk Areas* is the result of a multi-stakeholder process that began in December 2009 as part of the OECD Pilot Project on Due Diligence in the Mining and Minerals Sector (see [www.oecd.org/daf/investment/mining](http://www.oecd.org/daf/investment/mining)).

The purpose of the Nairobi Consultation is to review and possibly agree on the general due diligence framework - which was endorsed in April 2010 at an expert meeting of the OECD-hosted working group - the Model Supply Chain Policy and the *Supplement on Tin, Tantalum and Tungsten (hereinafter "3Ts Supplement")*, which was revised in light of the comments received since April 2010. The consultation is also intended to discuss the merits of the creation of an institutionalised mechanism to support supply chain diligence as well as the possible development of an additional supplement on gold and/or other precious metals.

Participants are invited to file submissions stating their position with regard to the revised draft guidance and proposing specific amendments to the document for consideration during the meeting. Submissions should be sent to the OECD Secretariat ([tyler.gillard@oecd.org](mailto:tyler.gillard@oecd.org)) no later than September 27<sup>th</sup>.

Would companies adopt or integrate as appropriate Annex II into their corporate social responsibility and sustainability policies?
- Do the principles for risk mitigation in Annex III provide useful, yet flexible and practical guidance for companies? Are there additional indicators that can be used to track improvement?

**SESSION 3 - REVIEW OF THE 3Ts SUPPLEMENT**

In this session, participants are invited to consider the detailed recommendations put forward in the *3Ts Supplement*. This session will be divided into three sub-sessions. Each sub-session should focus on how existing international, regional or industry initiatives can be relied upon or better coordinated to discharge the recommendations contained in the supplement.

**Due diligence for upstream companies**

This session will review the specific due diligence recommendations addressed to upstream companies, which include local exporters from the country of mineral origin, international concentrate traders, mineral re-processors and smelters/refiners. The discussion will focus on establishing a system of transparency and control over the mineral supply chain [Step 1(C)] and risk assessments [Step 2].

**Due Diligence for downstream companies**

This session will review the due diligence recommendations addressed to downstream companies, which include metal traders, component manufacturers, product manufacturers, original equipment manufacturers (OEMs) and retailers. The discussion will focus on establishing a system of transparency and control over the mineral supply chain [Step 1(C)] and risk assessments [Step 2].

- Are downstream companies willing to participate in the implementation phase of the guidance and, if so, how could such an implementation phase be structured?

**Third-party audit of smelter/refiner's supply chain due diligence: towards a "Fair Mineral Association"?** The guidance offers two options for consideration on third-party independent audits of smelter/refiner's supply chain due diligence. The first reflects the current status of individual audits. The second one calls for the establishment of an institutionalised mechanism which, in co-operation with governments and civil society organisations, would oversee and support the implementation of the guidance, through audit oversight, suppliers capability-building, and grievances follow-up.

- How could a *Supplement on Gold and/or Other Precious Metals* address the challenges associated with conducting due diligence on scrap gold or other gold doré from artisanal and small-scale producers distributed into the market through informal channels?
