The OECD Global Anti-Corruption & Integrity Forum provides the opportunity to meet with government and business leaders, policy makers, anti-corruption experts and practitioners, civil society representatives and academics.

Every year, the Forum launches the Knowledge Partnership, which aims to enrich the content and perspectives of the Forum by bringing new insights from the field.

For the 2020 edition, a particular preference will be given to sessions linked to the overarching theme on how actors (public sector, businesses, civil society and individuals) can work together to promote a culture of integrity and anti-corruption.

Session requirements

Knowledge Partners are offered a **25-minute slot** in the agenda, in parallel of other sessions. This slot should feature:

- A presentation of a new report, new findings or new indicators relevant to the Forum in the form of a TED-like speech
- OR a debate with two people.

As the objective of the Forum is for participants to interact and contribute, **at least 10 minutes** should be dedicated to exchanges with the audience.

In line with the Forum's focus **on new insights, please note that priority will be given to new findings, data and/or evidence that were recently produced or yet-to-be launched.**

Partnership cross-promotion

Knowledge Partnerships are also based on **cross-promotion** to engage with key audiences and ensure that the event is both relevant and impactful.

Knowledge Partners are therefore expected to:

- Author (or co-author with the OECD) a blog article, to be published on their platform (or the OECD's)
- Announce the event on their website, and
- Promote the event, the session and the article on their communications channels (newsletter and social media platforms).

The Forum team will provide a promotional package with ready-made material to facilitate the dissemination.

The Forum commits on its side to acknowledge the Knowledge Partnership on the [website](#) and in the agenda. Blog articles could also feature in the OECD Integrity [Newsletter](#).

This proposal should take the form of 2-3 paragraphs describing the content of the presentation/debate and title. **1 October 2019**

OECD validates Knowledge Partnership

As only limited slots are available, the OECD may not be able to accept all proposals. In case of similar proposals, the OECD may also merge ideas. **31 October 2019**

Final session/speaker information

Includes session title and description, and speaker information (details to be provided at a later date). **15 January 2020**

Selection criteria

Please keep the following criteria in mind when proposing a session:

1. *Innovative research or evidence*
2. *Relevant to the integrity and anti-corruption field and overarching theme*
3. *Interactive element (includes a Q&A for example)*
4. *Accompanying publication or report and launch date, if relevant*
