The main steering documents for Sweden's trade-related development cooperation are the EU Strategy on Aid for Trade, The Swedish government's annual guidelines on Aid for Trade and Sida's (Swedish international development cooperation agency) operational "Plan for trade-related development cooperation". During 2009, Sweden will formulate a new policy on trade-related development cooperation (see Q 1.2).

All trade-related contributions should have a pro-poor growth and poverty reduction focus, be demand driven and integrated into the overall development cooperation. The focus for Sweden's trade-related development cooperation assistance is the poorest countries and the priority region is Sub-Saharan Africa.

In the EU context, Sweden and the UK are leading a working group on Aid for Trade: "Promoting inclusive growth and poverty reduction" This work is primarily designed to strengthen the pro-poor focus and quality of the EU Aid for Trade by further developing ways in which key stakeholders understand and act upon the linkages between trade, poverty and inequality. The annual Government guidelines on Aid for Trade make explicit the priority areas for Swedish trade-related development cooperation. Current priorities are: Sanitary and Phytosanitary measures (SPS), Technical Barriers to Trade (TBT), Economic Partnership Agreements (EPA) related support, Trade and Climate Change and Trade Facilitation. According to Sida's plan, trade-related support will be concentrated to: i) trade in agricultural products (SPS and TBT), ii) power trading, iii) transaction costs (Trade Facilitation and Transport), iv) trade development and v) research, training and policy processes. (When implementing, Sida will be aiming for larger contributions, sector concentration based on Swedish comparative advantage, longer contract periods and cooperation with other donors.)]

Trade and climate has been added to the list of priorities since 2007.

During 2009, Sweden will formulate a new Policy on Trade-related Development Cooperation. The policy will take its point of departure in the broader AfT definition. During the policy process, we will examine how Sweden should position itself, in light of Swedish competence, our priority countries, and profiles of other donors. How trade related assistance best can contribute to poverty reduction will be further examined. One important aspect of the policy will be to strengthening partner countries' ability to identify and coordinate trade related assistance needs.

#### **Mainstreaming and Ownership**

Integrating trade into overall development cooperation is a priority for the Swedish government. The operational plan of the implementing agency (Sida) called "Plan for trade-related development cooperation", focuses specifically on integration of AfT in other sectors.

Sida is currently implementing a major organisational re-structuring, which will increase opportunities for closer cooperation across different working areas. There are ongoing projects between different teams within Sida aiming to improve cooperation in relevant areas. Within the "Operations pillar" the global, regional and country teams consist of people from all different sectors, including experts in the economic and trade fields. Sweden has in 2008 developed many new country cooperation strategies. The majority of these include possibilities to meet partner countries' demand on trade-related development cooperation assistance within the field of market development and agriculture. Some of them also has AfT and market development as a specific priority sector.

Regional integration is an important part of the Swedish Aid for Trade strategy. Both as means to enhance regional South-South trade, but also as an important stepping stone to increased multilateral trade. Trade-related assistance can typically be more efficient when contributions at the bilateral level is supplemented by regional contributions, in order to create potential synergies.

The focus area of Swedish aid for trade is Sub-Saharan Africa. In accordance with the Joint EU-Africa Strategy for 2008-2013, trade and regional integration is one of the prioritised areas in relation to Africa. Trade is a cornerstone of the regional integration efforts of African countries and Sweden will work actively to respond to needs and demands for trade-related support at the regional level. Principal cooperation partners at the regional level will be regional organisations. Some examples are contributions to increased harmonisation and development of regulations and standards within agriculture (SPS and TBT), the development of regulatory frameworks, strengthening of institutions and infrastructure for power trading, transport and transaction costs. Moreover, research, education and policy processes have a clear regional dimension to support development of trade policy knowledge and capacity to formulate trade policies and negotiate. Sweden will support contributions that enhance the African countries' efforts to integrate at intraregional level as well as with the rest of the world.

Sweden is in the process of developing a new cooperation strategy for Africa, which will keep regional economic integration (including trade integration) as one of its main priorities.
