SHARING EVALUATION PLANS

* * *

In order to improve information sharing, transparency and facilitate identification of possible future collaboration, members of the DAC Evaluation Network have agreed to share evaluation plans and work programmes. At the Network's Sixth Meeting in June 2007, members welcomed the overview which the Secretariat presented of members' evaluation plans. The Secretariat has since continued to post member's evaluation plans on the Evaluation Network's restricted website: www.oecd.org/dac/evaluation/members.

This note has been prepared for the Seventh meeting of the Network, and is based on a request by the Secretariat to which a total of **20 agencies** (representing **18 members**) have responded. The information collected provides an overview of what areas, themes and topics will be evaluated over the next years and provides indications of similarities and common interests among members.

As can be seen from the plans below there are a great number of evaluations in various thematic areas as well as in different regions planned for the coming years. The plans also show that there are many evaluations which are in similar fields and/or undertaken in the same country or geographic area. For example, in 2008/2009 six evaluations by different donors are planned in Mozambique, five in Viet Nam, six in Uganda, and seven in Ethiopia. Looking at thematic evaluations, as many as eight evaluations in private sector development and public private cooperation are planned in the next couple of years. Moreover, fifteen evaluations are planned in the education sector, twelve in the water sector, thirteen in the environment sector, and six within technical assistance. This may provide opportunities for collaboration in various stages of the evaluation process in order to increase the relevance of individual evaluations and to minimise the work burden of partner countries.

In addition to the evaluations undertaken by central evaluation departments there will certainly also be a great number of decentralised and local level evaluations.

DENMARK 2008/2009

By early 2008, the Evaluation Department in Denmark had a total of nine ongoing evaluations and three evaluation studies were in process. The nine ongoing evaluations included the following bilateral evaluations: Country programme evaluations in Ghana, Benin and Mozambique; impact evaluation of aquaculture projects in Bangladesh; evaluation of Public Private Partnerships. In addition, the evaluation department was involved in three joint evaluations: the evaluation of Exit Management; the evaluation on support to Citizens Voice and Accountability and the evaluation of the implementation of the Paris declaration. The latter is expected to continue until 2009, while all other ongoing evaluations will be finalized in 2010.
