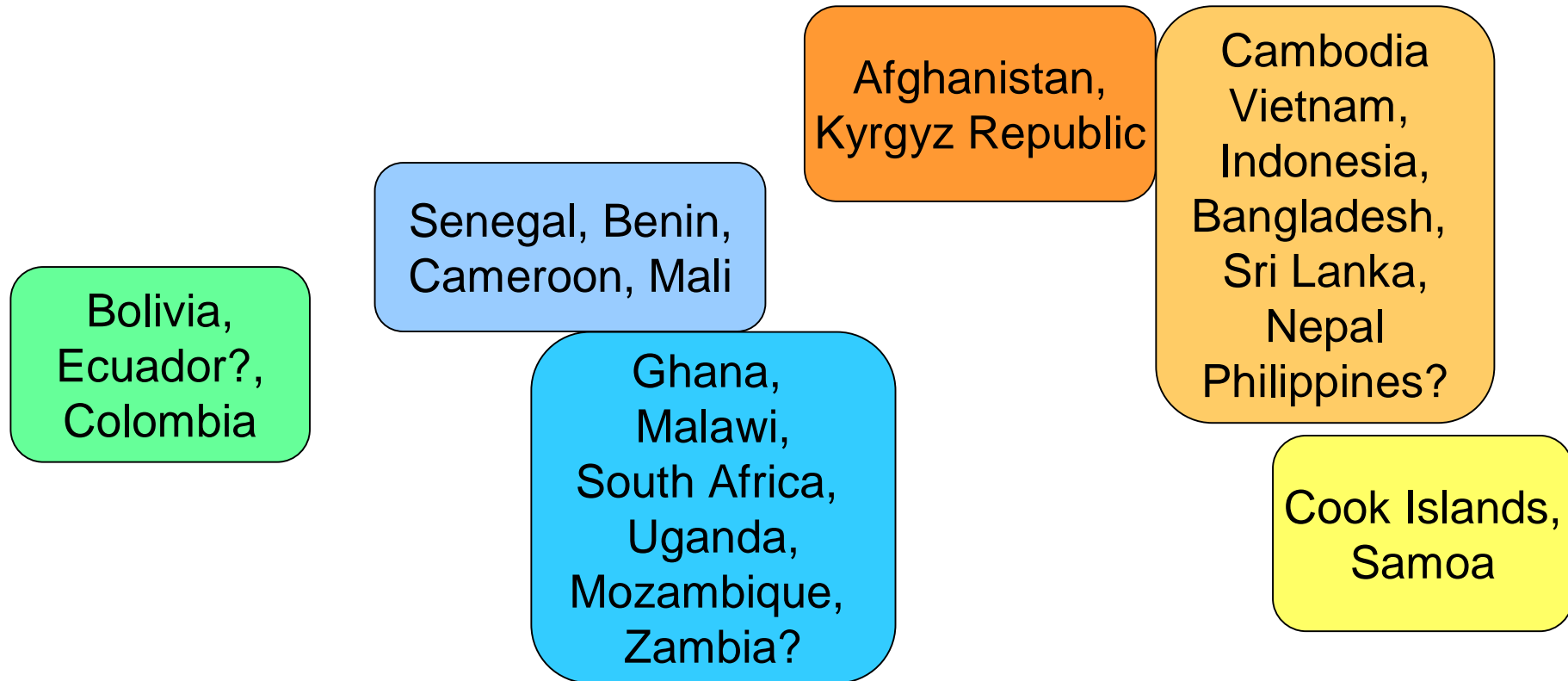

Evaluation Support Mechanisms

Core Evaluation Team

Support Mechanisms for Country Evaluation – a *Service*

- Started September 2009 and continues through to December 2010
- Focused on assuring quality to the ‘process’ and the ‘product’ of the Country Evaluation
- People based approach – using continuous communication and *engagement* at scheduled milestone points.
- Maximising opportunities for shared learning
- Result - getting all countries to complete *strong* evaluations (national/ global) within the timeframe set by the International Reference Group.

Countries / Regions



Elements of Support (1) – Start-up.

- Design of the Generic ToR including Common Evaluation Matrix [Regional Workshops Oct/ Nov 2009] & Outline for Country Evaluation Reports
- Comment on drafts of Country specific ToR, if asked.
- Offer professional advice on the selection, contracting and briefing of Country Evaluation Teams [includes Team Leader orientation ‘workshops’ Feb/ March 2010]
- Review and collate relevant existing research and evaluations – provide a ‘starting point’ of background information on the substantive issues relevant to the common core questions [Literature Review]
- A pack of key documents that Evaluation Teams are likely to draw on in carrying out their Country Evaluation [Country Dossiers]

Input to selection & contracting of evaluation teams by national procedures

- Provide generic professional qualifications for an effective team
- Can offer a perspective to any questions arising on team balance
- Maintain an overview of the composition of Evaluation teams across the participating countries

Team Leader orientation

- A round of regional or sub-regional meetings involving Team Leaders and (tbc) a selection of other team members and the National Evaluation Coordinator
- Meetings focused on working through sources of evidence and common methods and tools for use in Country Evaluations

Literature review

- A focused search of the literature 2005 onwards
- To ensure Phase 2 Evaluation reflects best current research (global, regional & national) and builds on earlier work for Approach Paper
- Short list of key references against each of the core Questions by Jan 2010, ongoing review thereafter.
- *Country contribution*: To identify and supply – through the Country Dossier tool - any key references relevant to the country/ regional context

Country Dossiers

- A “Getting started” pack – see draft Contents handout.
- To make it easier to get started by offering a skeleton of key information.
- To be shared before the round of Team Leader orientation meetings.
- *Country contribution*: To continue to flesh out the Country Dossier as key documents/ pieces of information emerge through the evaluation process.

Elements of Support (2) – Evaluation

Evaluation support to engage long-distance or (to extent CET resources allow) in country at key milestones:

- Event: Presentation/ discussion of each country Evaluation Workplan (including Matrix)
- Event: Presentation/ discussion of each Evaluation Inception Report
- Stage where Team analyses evidence & prepares “emerging findings”
- Event: Presentation/ discussion of Draft Evaluation Report

This engagement along the way by the CET with country studies will also strengthen the Synthesis later.

Continuous Quality Assurance

- Open channel of communication between country and Core Evaluation Team.
- Bi-monthly monitoring reports on evaluation progress.
- “Trouble-shooting” capacity.

Knowledge Management / Extranet

Objective:

To manage and share electronic documentation and communication within teams and between teams, including Secretariat, Reference Groups and Management Groups

Core functions:

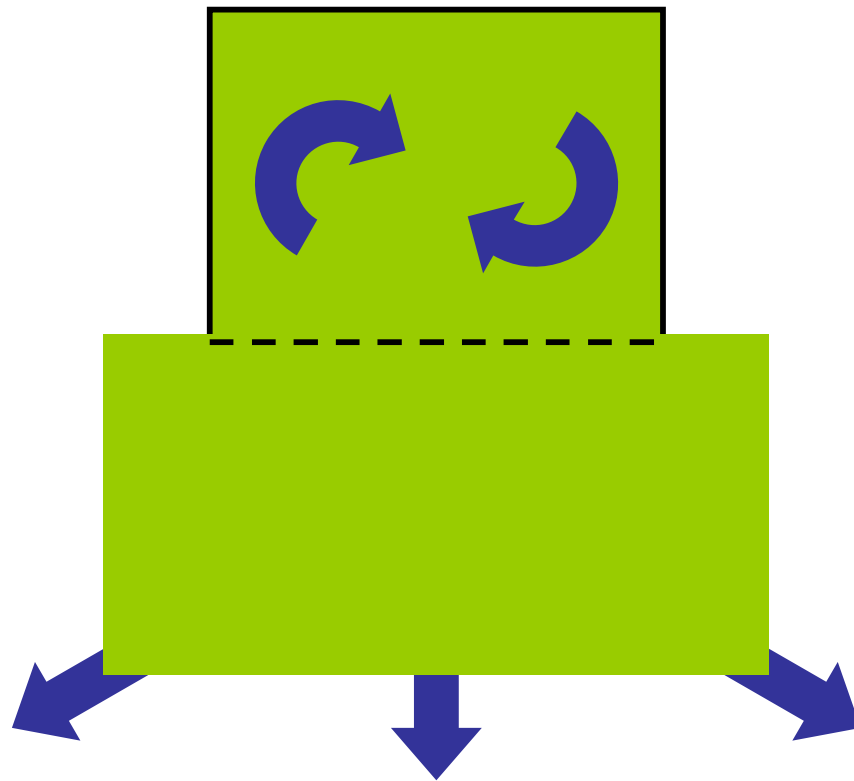
1. Electronic filing, information management and version tracking (a **Library**)
2. Activity and milestone tracking (a **Calendar / Diary**)
3. Inter- and intra- team communication, advice and support (a **Support Centre**)

Development:

- Phased development Sep-Dec 2009, including user testing with Core and Country Teams
- Ongoing technical support and guidance provided via central team

Knowledge Management / Extranet

Simple, tailor made extranet being developed for each team, to feature...

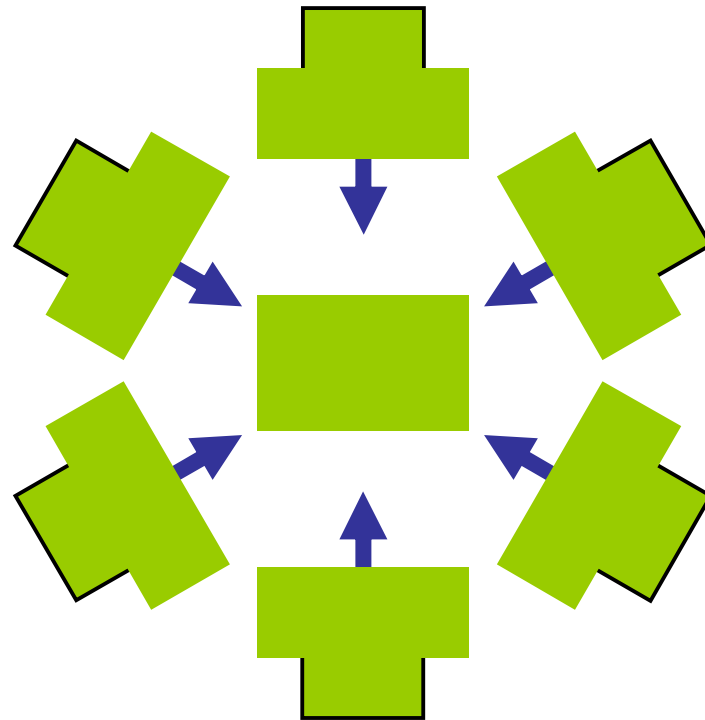


Secure areas enabling communication and document development **within** team
