Civil Society Policy Goal

To strengthen and widen the space for men and women to act collectively and to participate in sustainable development processes.

Specific Objectives

1. *To support an enabling environment for civil society to organise and engage with government and its own broader constituencies; and*
2. *To support the role of civil society:*
 - *in promoting participation and good governance;*
 - *in ensuring better service delivery and economic development; and*
 - *globally and nationally, to build a constituency for development, human rights and social justice.*



IA Support to Civil Society

- HQ based funding schemes
 - Multi Annual Programme Scheme
 - Civil Society Fund
- CSO funding schemes in bilateral programmes
- Emergency and Relief
- Multilateral support



Multi Annual Programme Scheme (MAPS)

- A supportive framework of funding
- Poverty focused development outcomes and impacts
- Programmatic approach linked to an organisational strategic plan
- Targeted at Irish-based NGOs with a track record
- Five strategic partners
- Predictable, long-term (5-year) funding



MAPS – Gender Equality

Through Policy Level Objectives...

- To address the multi-dimensional aspects of poverty and vulnerability
- To promote justice and equality, especially gender equality;
- The development of autonomous civil society organisations and communities
- Human rights

Through Process Level Objectives...

- To develop structures and processes that support and embed mainstreaming;
- To promote innovation and lesson-learning
- To demonstrate outcome and impact at a strategic level;



MAPS – Gender Equality

- Gender Equality
 - Cross cutting Issue
 - Mainstreamed
- Gender Based Violence
 - Institutionalising prevention and responses to GBV in programme




Civil Society Fund (CSF)

- CSF replaced 8 different civil society funding schemes
- Designed to be flexible
 - broad range of applications, from small micro-projects to 3-year programme proposals
- The overall objective of the CSF is
 - ❖ *to contribute to the achievement of the Millennium Development Goals by improving the livelihoods of disadvantaged communities in developing countries.*



CSF thematic priorities

- Four thematic priorities (Gender Equality, HIV/AIDS, Human Rights, Environment & Sustainable Development)
- Gender Equality
 - Cross-cutting issue/mainstreamed
 - The CSF prioritises interventions aimed at the empowerment of women and/or tackling gender inequality.
 - Specific support for interventions aimed at tackling gender-based violence at an institutional and programme level.



Joint Consortium on Gender Based Violence

- Irish Aid, Irish Development, Humanitarian and Human Rights NGOs and the Defence Force came together to form a consortium with a focus on tackling GBV

- The consortium is funded by the membership and has:
 - Produced guidelines on developing a strategy for preventing and responding to GBV
 - Produced guidelines on institutionalising GBV within organisations
 - Undertaken joint advocacy work on GBV
