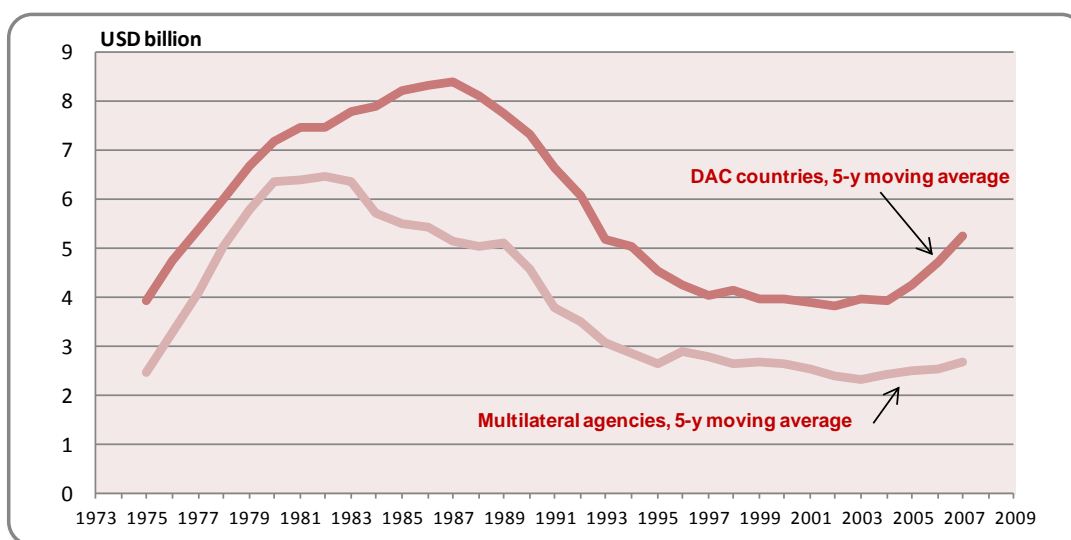


# Aid to agriculture and rural development

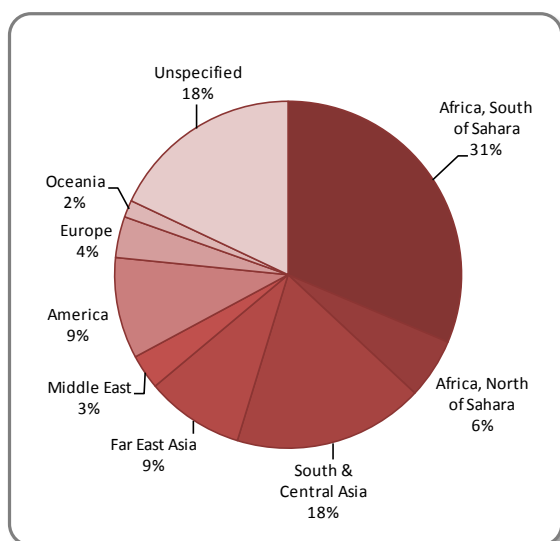

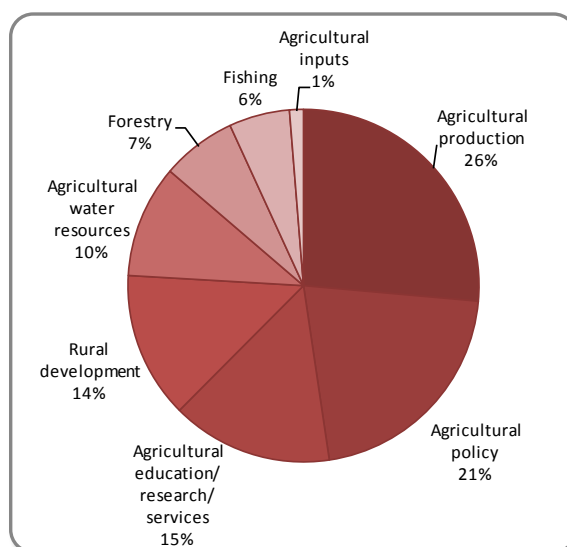
**Chart 2. Regional breakdown of aid to ARD**

2008-09, bilateral and multilateral commitments, constant 2009 prices



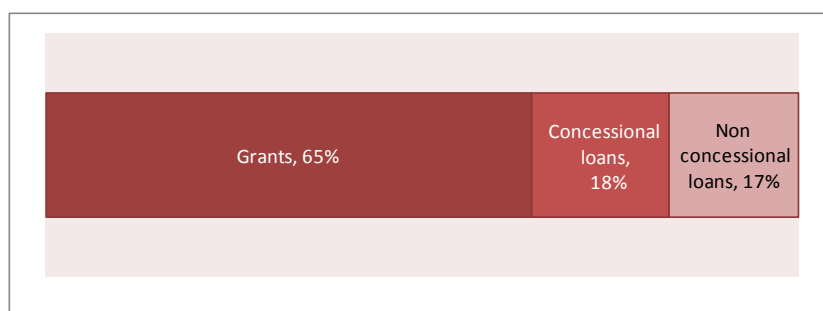
**Chart 3. Sub-sectoral breakdown of aid to ARD**

2008-09, bilateral and multilateral commitments, constant 2009 prices



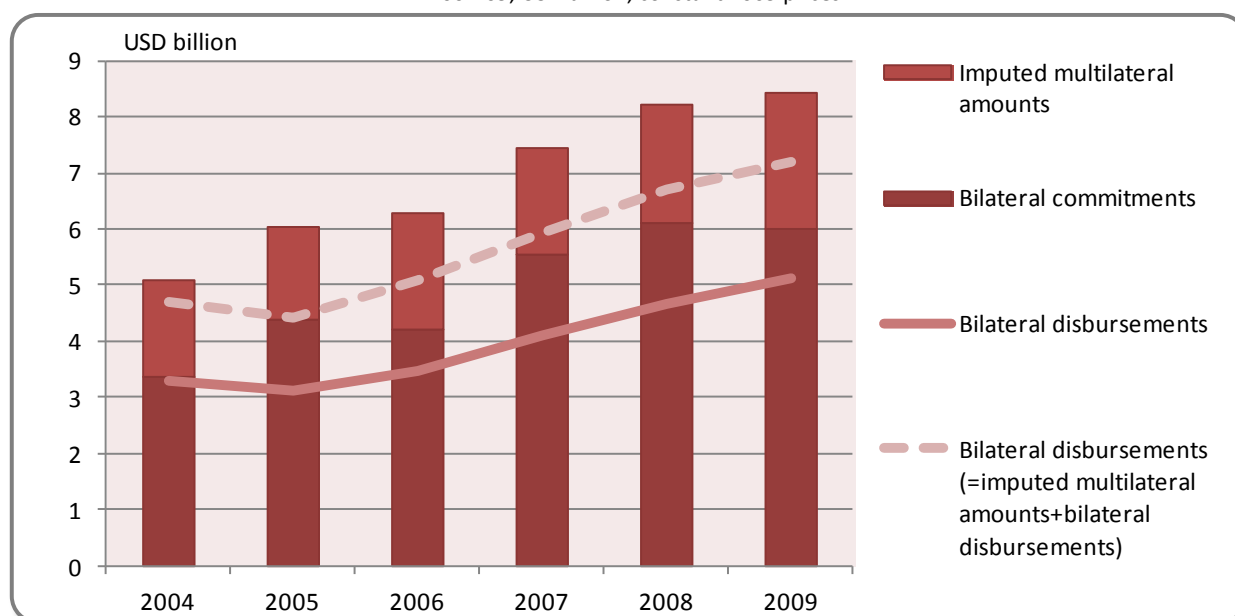

2008-09, annual average commitments, USD billion, constant 2009 prices

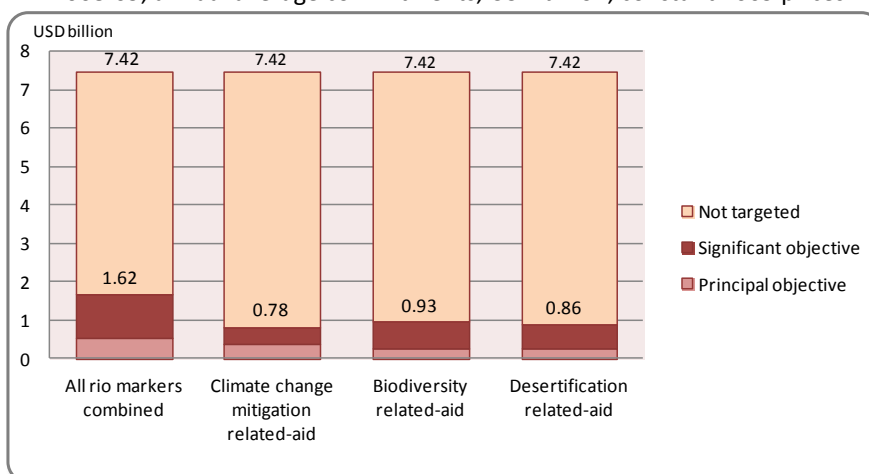
