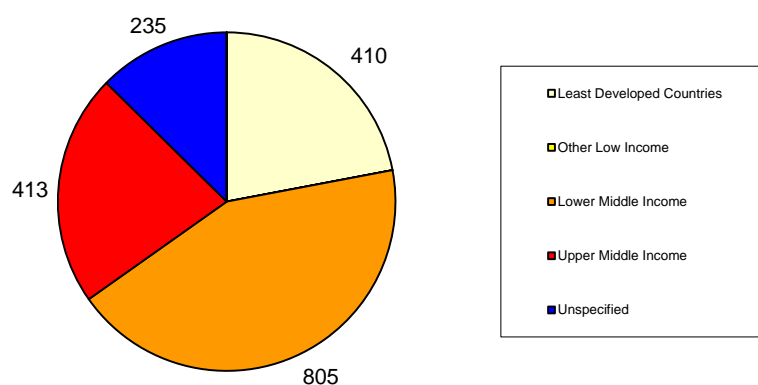

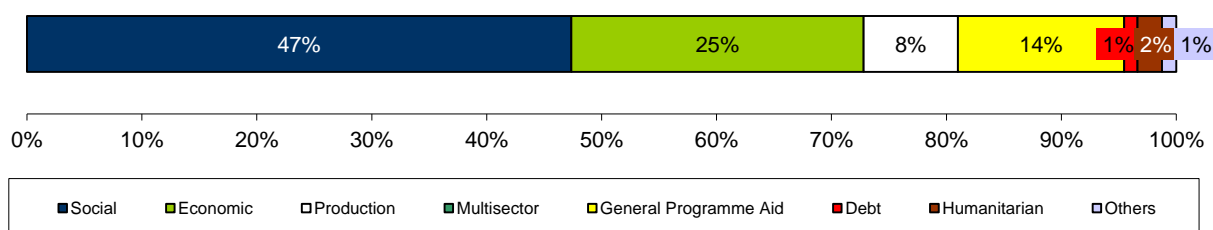
6.1.4. ODA by income group USD million, 2014, net disbursements

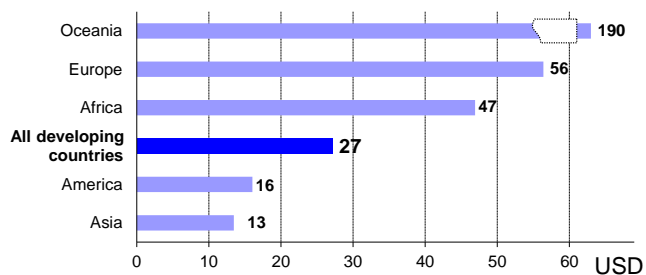

6.1.5. Sectors in 2014 commitments



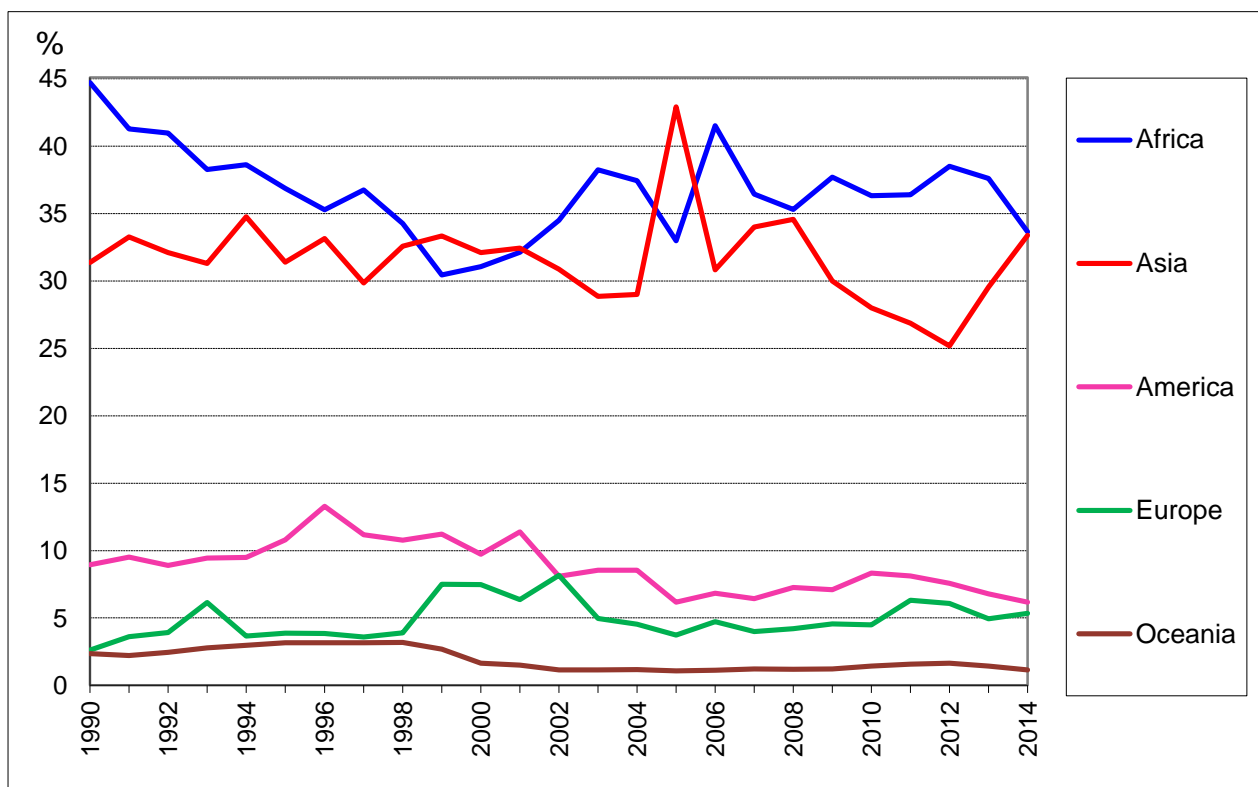
6.1.6. Net ODA receipts per capita in 2014

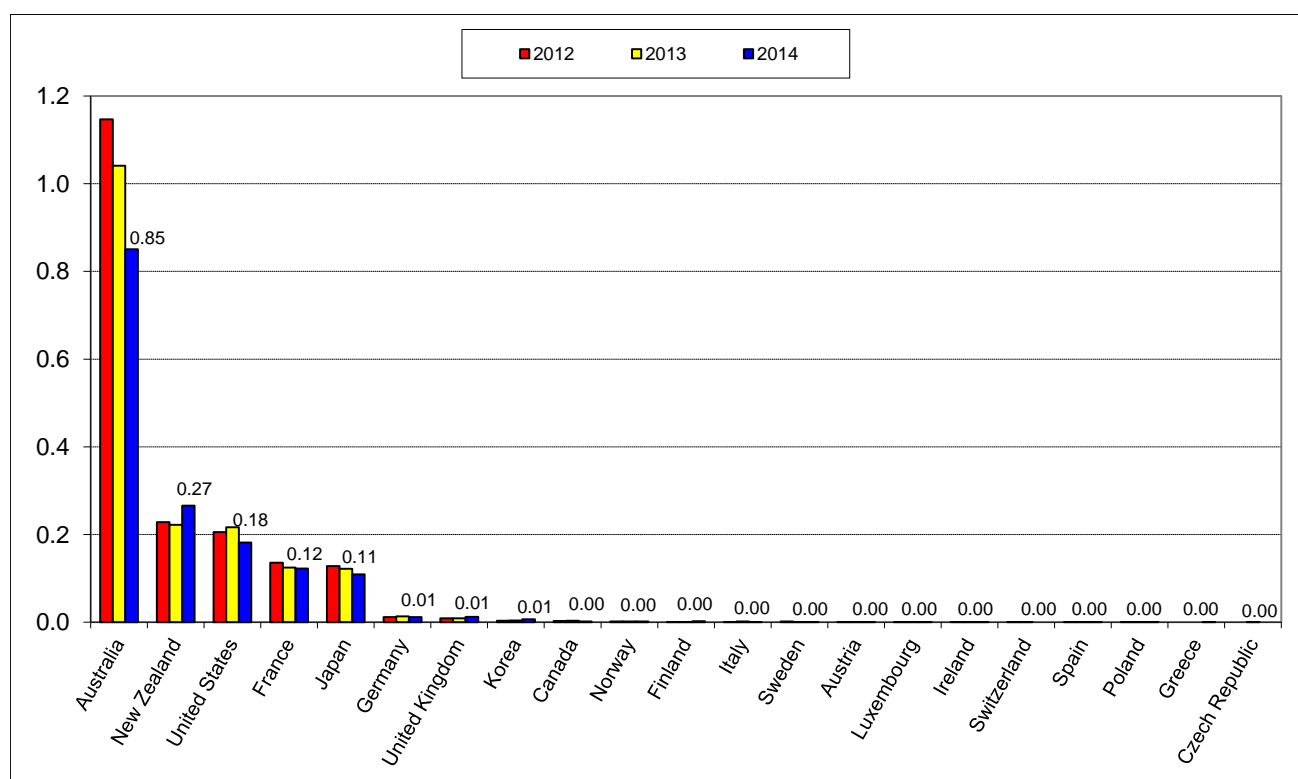

USD billion, values shown for 2014, net bilateral disbursements



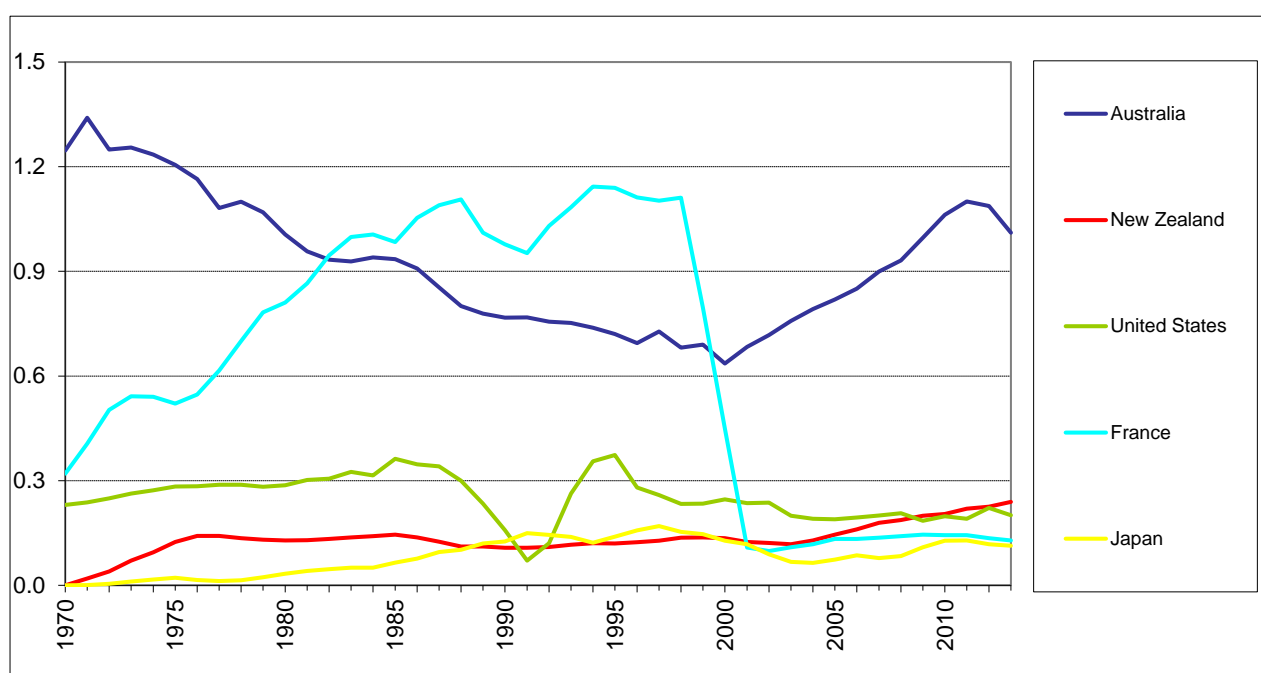

6.2.4. ODA to Oceania by largest bilateral donors since 1970

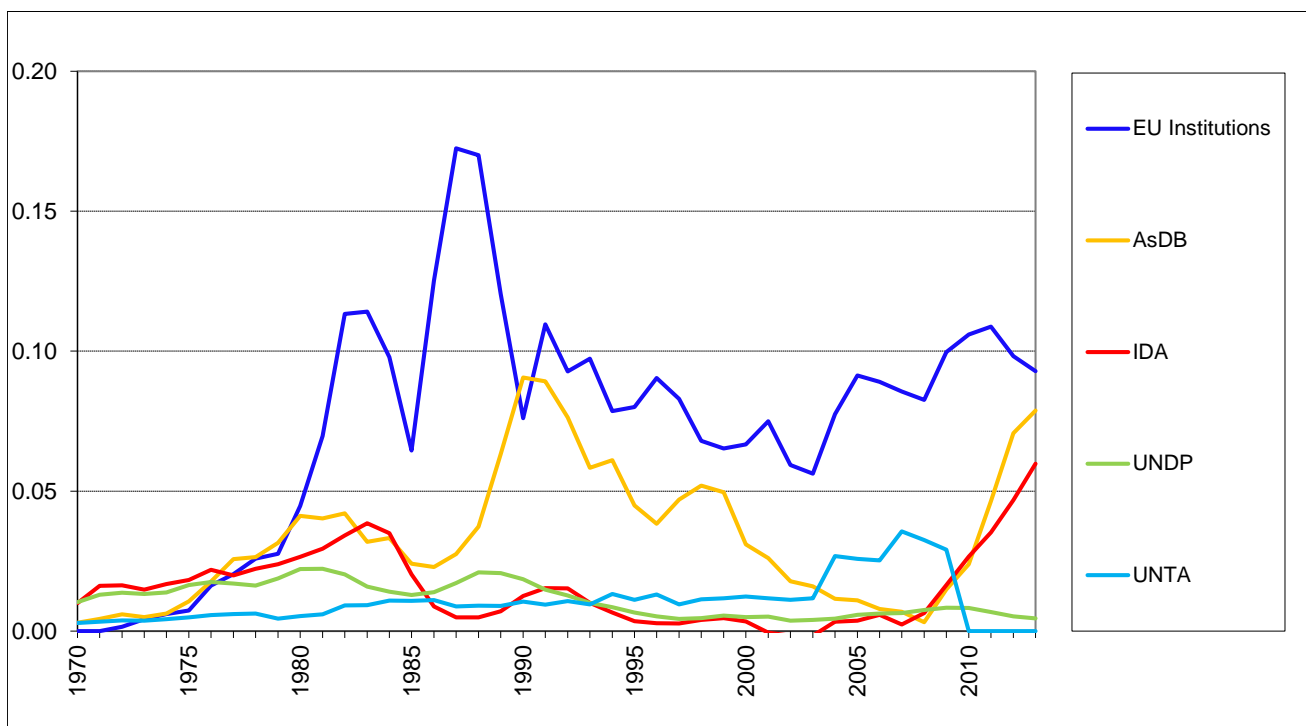
USD billion, 2014 prices and exchange rates, 3-year average net bilateral disbursements

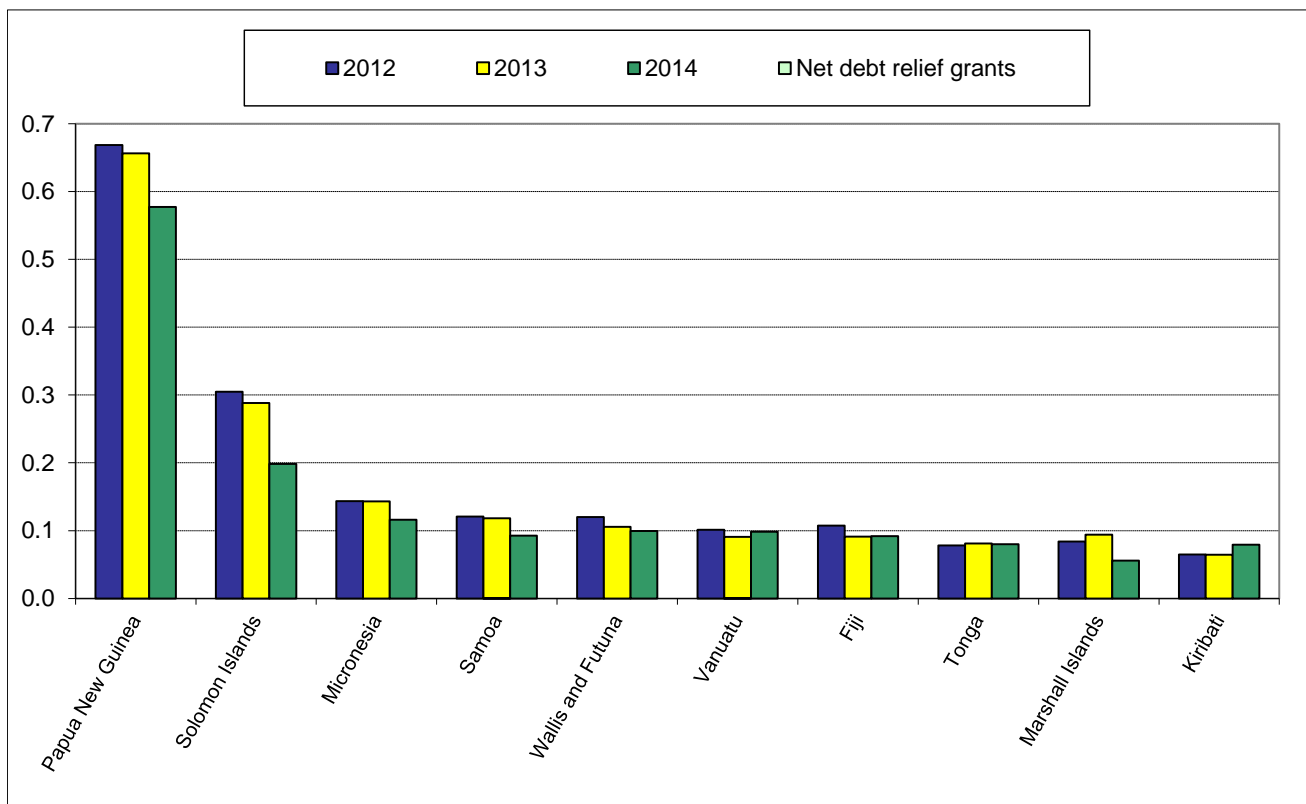
6.2.6. ODA to Oceania by largest multilateral donors since 1970

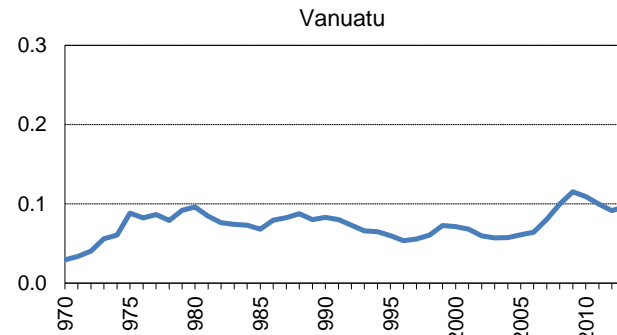
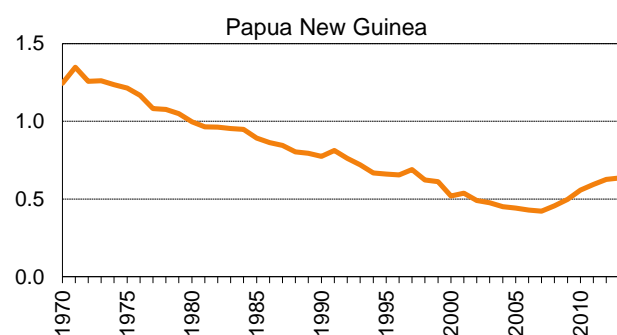
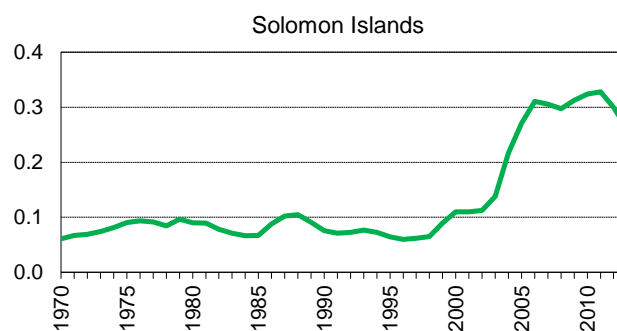
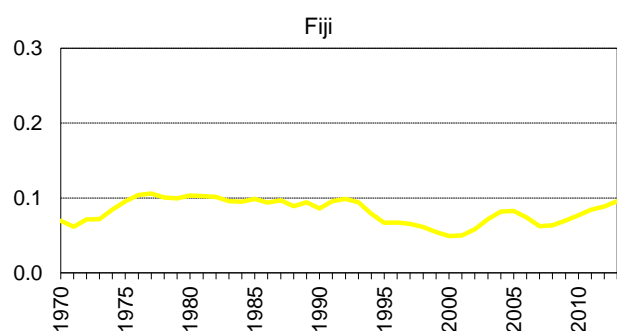
6.2.8. Top 10 ODA recipients in Oceania with their share of net debt relief grants

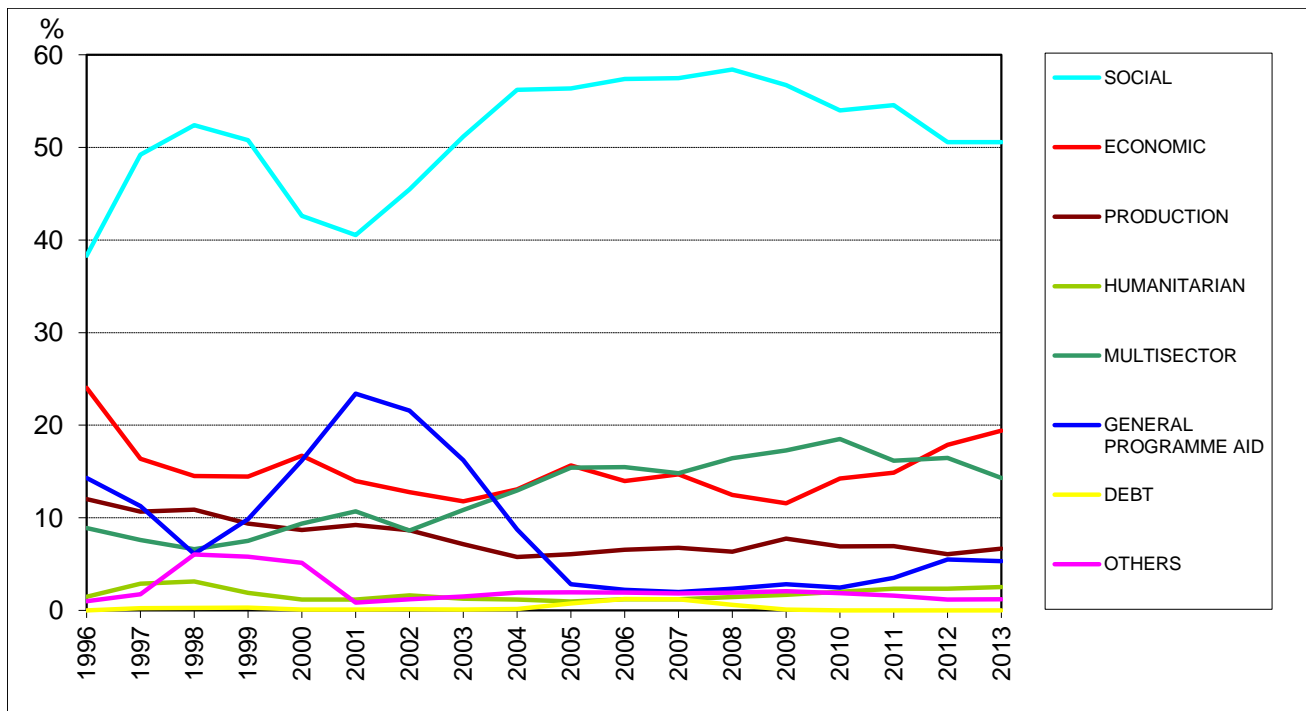
6.2.10. Trends in aid to largest Oceanian recipients since 1970

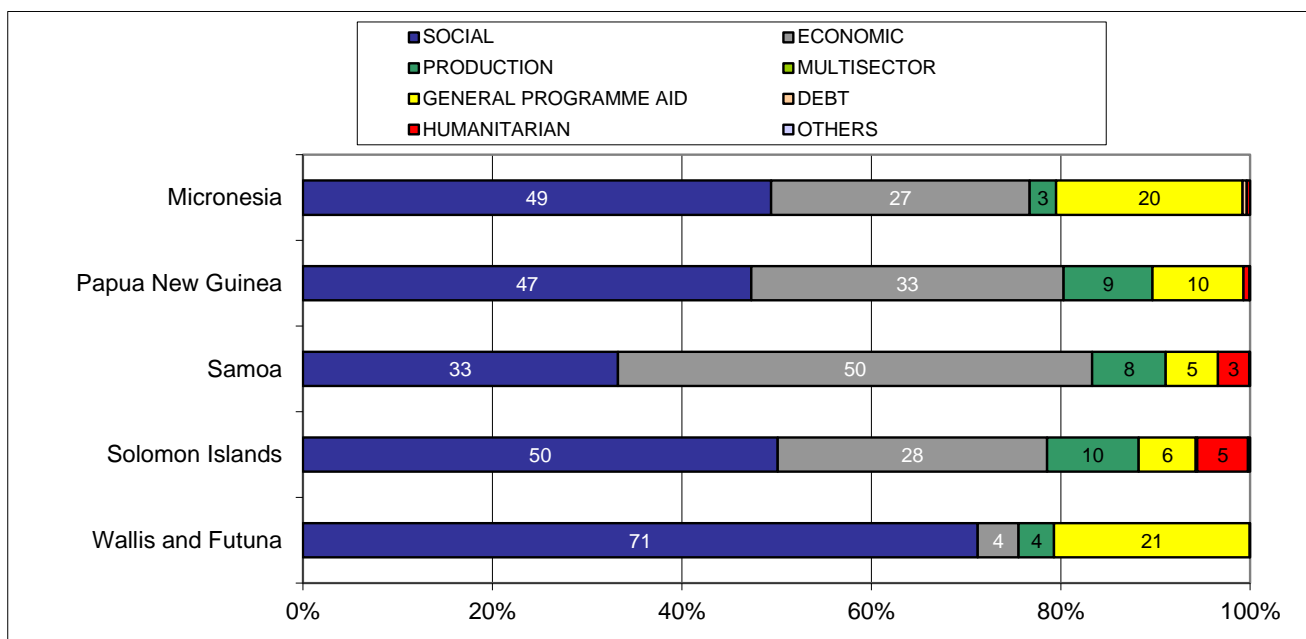
6.3.1. ODA to Oceania by sector since 1996

As a percentage of total ODA committed for each country



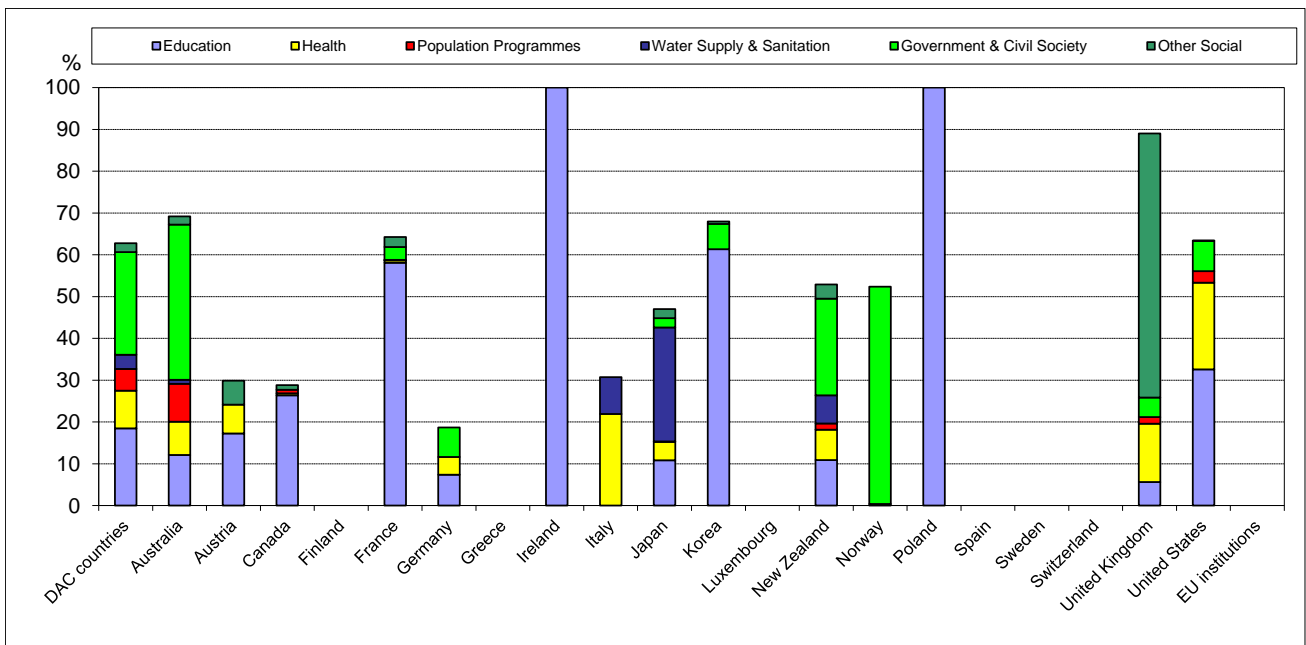

As a percentage of total bilateral commitments

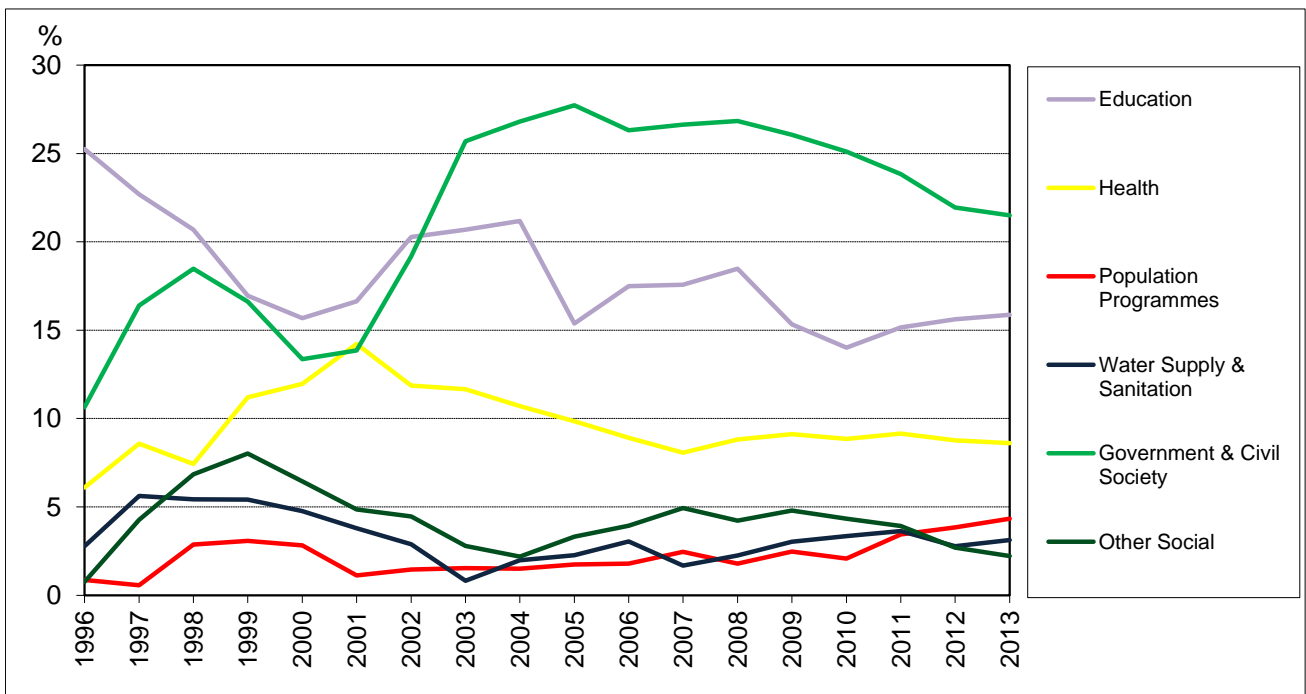

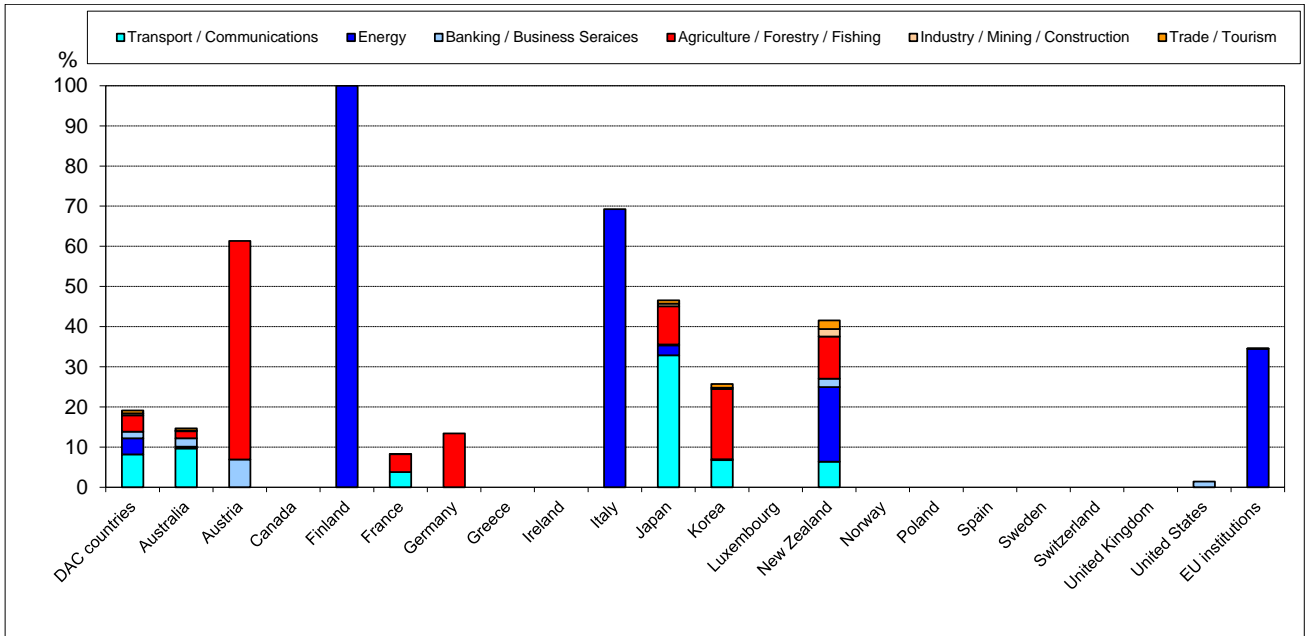
6.3.4. Analysis of social sector ODA to Oceania by donor
