Objectives and agenda of the 5th Steering Group meeting

The 5th Steering Group Meeting of the ADB/OECD Anti-Corruption Initiative for Asia-Pacific has four main objectives: To report on ongoing activities of both the endorsing countries and the Initiative's Secretariat; to review and finalize the stocktaking report; to present and discuss the countries' planned anti-corruption efforts under the Action Plan's second implementation cycle; and to table and approve upon the future strategy and activities of the Initiative.

■ Roundtable on current anti-corruption efforts

As foreseen under the Action Plan's implementation mechanism, the regular Steering Group meetings provide an opportunity to inform the partner countries under the Initiative and the members of the Advisory Group about current anti-corruption efforts, achievements, and priorities. Each country is invited to briefly outline recent anti-corruption trends, policies, and reforms. Participants are also encouraged to report on anti-corruption projects in which they are not directly involved but which play a key role in their countries' anti-corruption strategy.

Information collected during this roundtable will feed into the Initiative's stocktaking report on countries' anti-corruption efforts to ensure the accuracy and timeliness of this key benchmarking instrument.

■ 2nd Action Plan implementation cycle: Discussion of country priority areas and reform projects

The 5th Steering Group meeting marks the beginning of the second implementation cycle of the Anti-Corruption Action Plan for Asia-Pacific. In accordance with the Plan's implementation mechanism and commitments made there under, the endorsing countries are requested to present their second set of priorities for reform and the respective projects to achieve these reform goals (Doc. StG05-0704(5)).

This early discussion of country projects aims to ensure a comprehensive project design, to anticipate possible difficulties in implementing reforms and to prepare respective countermeasures, and to encourage support where necessary from partner countries, members of the Advisory Group, or the Secretariat.

■ Donor assistance

The Secretariat aims to assist interested countries in enhancing the support by and direct involvement of donor institutions in countries' efforts to implement the Action Plan. This includes the stages of selecting reform priorities, developing corresponding projects and actual implementation at national

level. Countries will be invited in this session to present in detail their needs for financial or/and technical assistance for the implementation of their second set of priority areas. Donor institutions represented in the Advisory Group will reflect on these proposals and report back to their headquarters and respective local field offices.

In this context, the Secretariat also offers assistance in establishing local donor consultation groups or ad hoc meetings, circulate the countries' reform projects under the Action Plan to interested donors and in particular to the donor institutions of ADB and OECD Members, and establish contact with experts that could assist in a country's reform efforts. The 5th Steering Group meeting will provide an opportunity to discuss the countries' interest in this form of assistance and to decide on possible formats of such support.

■ **Stocktaking**

Following an earlier decision of the Steering Group, the participating countries have taken stock of their legal and institutional frameworks to combat corruption. Based on the countries' reports, the Secretariat has compiled a summary overview of the current anti-corruption framework in endorsing countries from Asia and the Pacific. A first preliminary draft report, then covering sixteen countries, has been reviewed and adopted in the course of the 4th Steering Group meeting in December 2003. Four more countries have since submitted respective information, which has been integrated into the report.

The 5th Steering Group meeting provides an opportunity to discuss and review these additions and finalize the report as a whole, so that it may – after approval by the Steering Group – be published in its 2004-version in book form and made accessible to the public via the Initiative's website (Doc. StG05-0704(3)).

■ **Strategy and work plan 2004-2006**

Significant results have been achieved since the adoption of the Action Plan in Tokyo in November 2001, but further efforts are required to build up sustainable legal and institutional frameworks to combat corruption in the region.

In order to coordinate and determine the future priorities and activities of the Initiative in support of these efforts, the Steering Group will discuss and adopt the Initiative's strategy and work plan 2004-2006 which has been drafted by the Initiative's Secretariat based on earlier discussions in the Steering Group and with the Advisory Group (Doc. StG05-0704(4)). Members of the Steering Group will be invited to comment and suggest amendments to this document where required.

Particular attention will have to be paid in the discussion of this strategy to the definition of future training seminars and the preparation of the thematic review under the Initiative.

■ **Training seminars**

After the successful accomplishment of the Initiative's "Master Training Seminar on Effective Prosecution of Corruption" in 2003 and the Steering Group's call for continuous capacity building support from the Secretariat, the Initiative will hold its next training seminar on "Curbing Corruption in Public Procurement" back to back with the 5th Steering Group Meeting (Doc. StG05-0704(6)). As countries have expressed interest in continuing this series of capacity building events, the participants of the 5th Steering Group meeting will discuss and decide upon priorities and issues of future trainings.



■ Thematic reviews

As proposed and deliberated during the 4th Steering Group meeting, the Initiative plans to launch a series of thematic country reviews (Doc. StG05-0704(7)). These in-depth studies would serve as a practical tool and indicator in the hands of participating governments to manage and track the effectiveness of their individual reform measures. They would in particular support the countries that have signed the UN Convention against Corruption or plan to do so in their efforts to implement the commitments made there under. Based on participating countries' replies to a questionnaire developed by the Secretariat and on additional existing information, the thematic country reviews will allow measuring in an open manner the progress of participating countries in meeting the policy reform goals that they have set.

The 5th Steering Group meeting in this view provides an opportunity to discuss and agree upon the focus of the first thematic review as well as the methodology.
