# OECD Statistical Packages

Continually seeking to improve our subscribers' experience with OECD data, for 2012 we have created new mini packages based on the statistical databases. As well as the interactive edition, a subscription now includes the corresponding periodical, available as ready-made tables in three formats - PDF, XLS and Web (HTML).

By providing access to all available versions, the mini statistics packages simplify and enrich the user-experience, whilst also keeping administrative costs to a minimum. For example, a single annual subscription now covers all OECD National Accounts publications.

There has been no change to the titles of the mini statistics packages, and despite the considerable added value, we have kept price increases as low as possible. The mini statistics packages have increased in EUR by 7%, whilst the full OECD Statistics package has gone up by 6%. 'Online only' remains the most cost-effective purchasing solution, whilst associated print and archive CD-Roms are available as an option.
