RATIONALE

The meeting aims at briefing OECD delegations on progress and planning of future work of the GfD as well as an exchange with the co-ordinators with the six Arab countries chairing working groups.

The meeting is following the meeting of the national coordinators with the OECD and UNDP secretariat. Its main objectives are to foster a frank exchange on the experiences with the Initiative so far and a discussion on ways forward. The meeting further aims at discussing and contributing to the preparation of the Steering Group Meeting at Ministerial Level in Sharm-el-Sheikh in May 2006.

In particular, discussions will focus on:

- Experiences with the policy dialogue in the regional working group meetings so far.
- The future strategic direction of the Initiative both as
 - A forum for regional policy dialogue and exchange of best practice, and
 - A platform to facilitate donor support for public sector modernization programmes
- Preparations of Country Action Plans, proposals for pilot projects, and facilitation of matching Country Action Plans with potential bilateral support programmes.
- Potential outputs of the Steering Group Meeting at Ministerial Level, including a joint statement on the Country Action Plans
