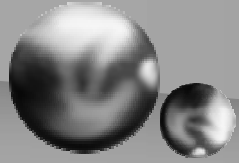

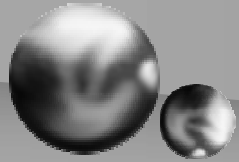

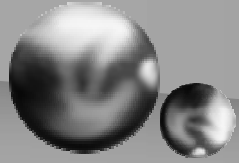


MENA RCGI Mission

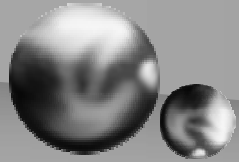

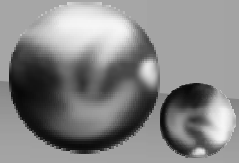

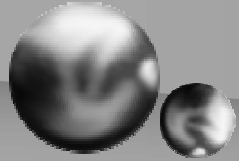
