OECD Unemployment Rate increases to 6.5% in November 2008

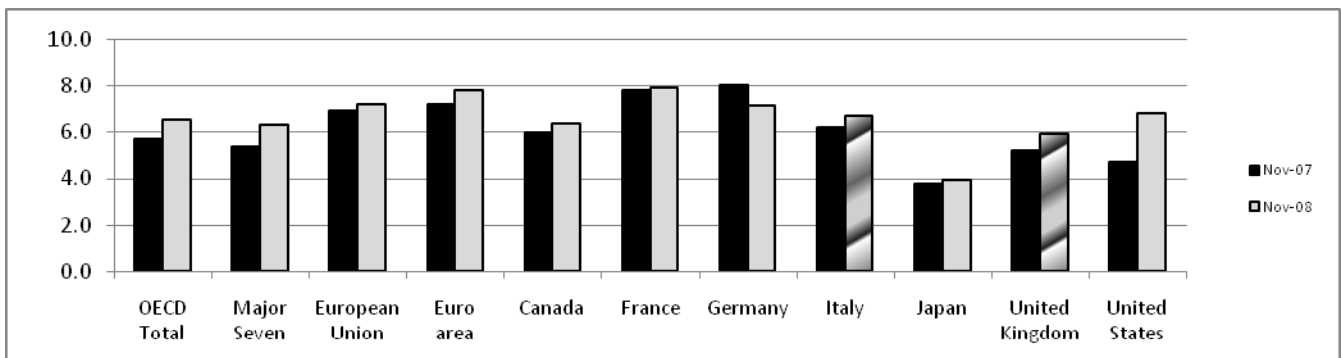
The unemployment rate for the **OECD area** was 6.5% in November 2008, 0.1 percentage point higher than the previous month and 0.8 percentage point higher than a year earlier.

In the **Euro area**, the unemployment rate was 7.8% in November 2008, 0.1 percentage point higher than the previous month and 0.6 percentage point higher than a year earlier. For the **United States** the unemployment rate for *December* 2008 was 7.2%, 0.4 percentage point higher than the previous month and 2.3 percentage points higher than a year earlier. For **Japan**, the rate was 4.0% in November 2008, 0.3 percentage point higher than the previous month and 0.2 percentage point higher than in November 2007.

In November 2008, the unemployment rate for **France** was 7.9%, 0.1 percentage point higher than the previous month and 0.1 percentage point higher than a year earlier. For **Germany**, the rate was 7.1% in November 2008, the same as the previous month and 0.9 percentage point lower than in November 2007. For **Canada**, the unemployment rate was 6.6% in *December* 2008, 0.3 percentage point higher the previous month and 0.6 percentage point higher than a year earlier. In *September* 2008, the rate in the **United Kingdom** was 5.9%, 0.1 percentage point higher than the previous month and 0.7 percentage point higher than in *September* 2007. In *September* 2008, the unemployment rate in **Italy** was 6.7%, the same as the previous month and 0.5 percentage point higher than a year earlier

OECD Harmonised Unemployment Rates

Methodological Notes

The OECD harmonised unemployment rates, compiled for 30 OECD member countries, are based on definitions of the 13th Conference of Labour Statisticians (generally referred to as the ILO guidelines). Under these definitions, the unemployed are persons of working age who, in the reference period, are without work, are available for work and have taken specific steps to find work.

The uniform application of the definitions results in estimates that are more internationally comparable than those based on national definitions. For example, national unemployment data in some countries only include persons registered at government labour offices. Under the ILO definition, persons without work who are seeking employment through other means can also be classified as unemployed and registrants can be excluded if they worked or were not available for work. The unemployment rates shown here are calculated as the number of unemployed persons as a percentage of the labour force (i.e., the unemployed plus those in employment) and are seasonally adjusted.

The unemployment rates for the European Union (EU) member countries and Norway are produced by the Statistical Office of the European Communities (Eurostat). The OECD is responsible for collecting data and calculating unemployment rates for the remaining OECD member countries.

In September 2000, Eurostat adopted a new unemployment definition through a Commission Regulation. Details about the new definition and its implementation are available on the [Eurostat Internet site](#). This link also gives details about country specific estimations and provisional data.

Monthly figures include OECD Secretariat estimates for countries which only compile quarterly rates.
