Detailed payment instructions will be provided in an invoice that will be sent to you on receipt of your registration form. Payment must be made within 15 days of receipt of the invoice. Confirmation of registration will be sent to you after payment has been received.

4. TERMS AND CONDITIONS

The registration fee covers attendance and conference papers, as well as one lunch, refreshments and a cocktail. The fee does not include accommodation or transportation.

Speakers, content and panel order are subject to change without notice, and registration may be limited. This meeting is subject to cancellation due to insufficient registration or other reasons, in which case refunds will be made free of processing fees.

If you wish to cancel your registration you may submit a refund request in writing, which must be received by **1 August 2009**. Please note that this will be subject to a 250 EUR processing fee. All refunds are limited to the amount of registration fees previously paid less the above processing fee.

After 1 August 2009, no refunds can be made for registration fees; however your registration can be transferred to a substitute before the Conference. Only one transfer/substitute per registration.
