



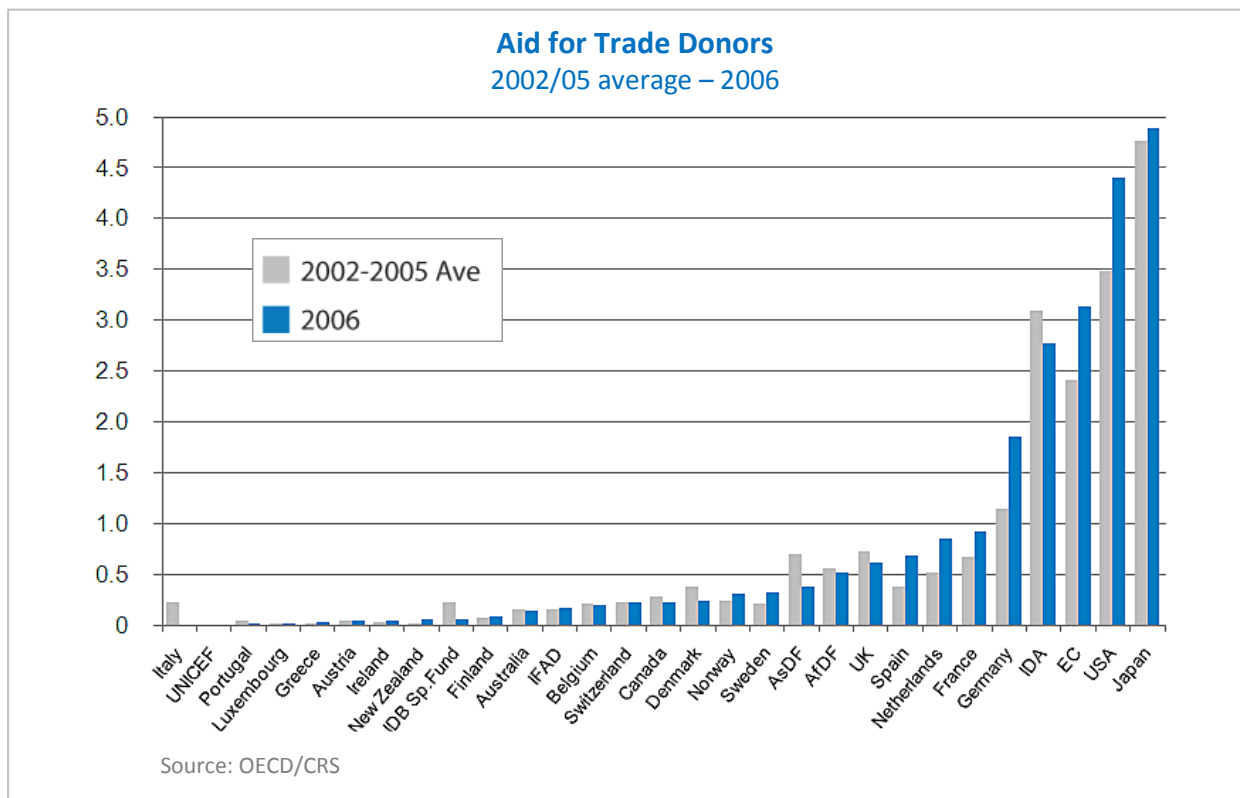
# AID FOR TRADE FLOWS INCREASED IN 2006



In 2006, total Aid for Trade commitments from bilateral and multilateral donors rose to USD 23 billion in real terms, compared to an average annual flow of USD 20.8 billion during the 2002-2005 baseline period.<sup>1</sup> This constitutes a real growth of 10%. These figures only relate to official development assistance (ODA) and exclude non-concessional loans from the international financing institutions, which amounted to an annual average flow of USD 10 billion during the baseline period.

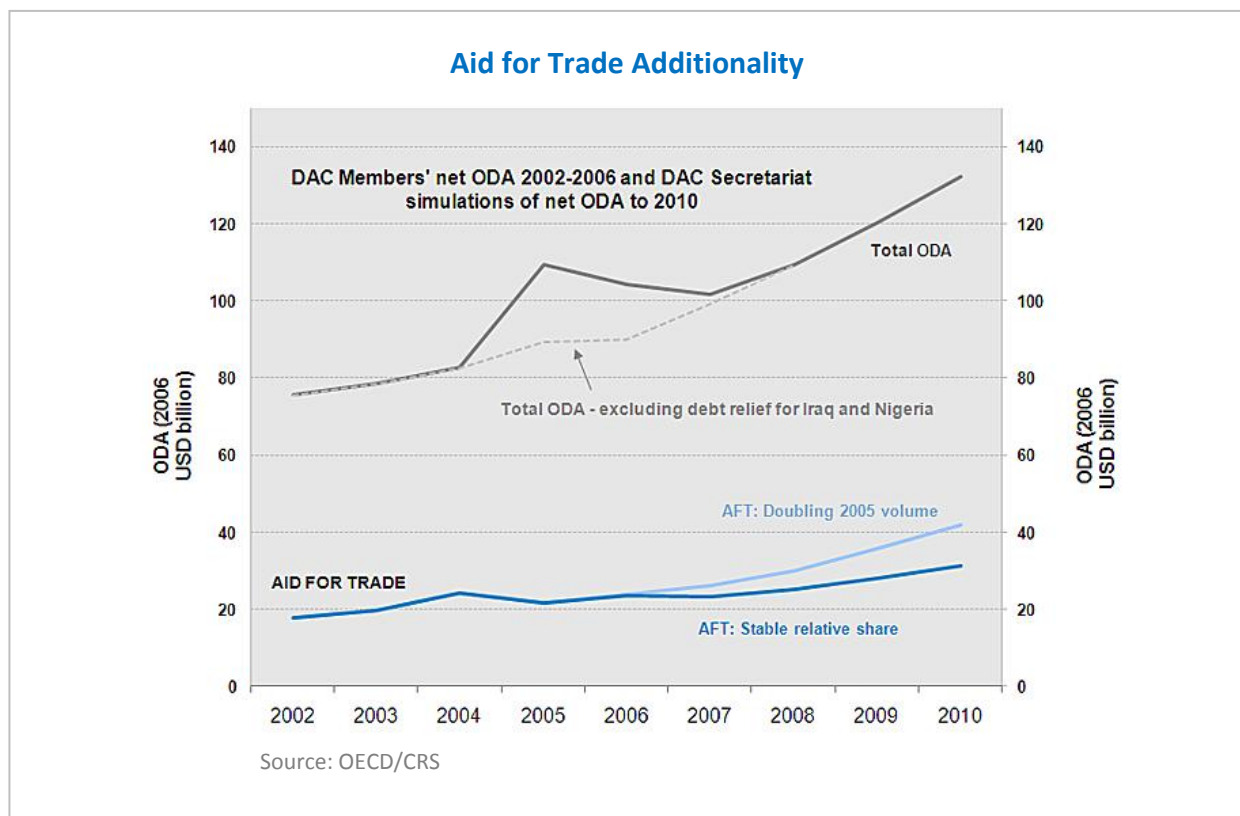
## Hong Kong pledges are materialising

The average increase in Aid for Trade commitments from bilateral donors alone was 16% in 2006. Several donors, including Germany, the Netherlands, Spain and Sweden, increased their Aid for Trade programmes by more than 50%. Others, such as the European Commission, France, Ireland, Norway and the United States expanded their programmes by more than one-third. Many of these significant increases in donor funding are in line with the Aid for Trade pledges some of these countries made during the 2005 Hong Kong WTO Ministerial Conference.



In the context of aid for trade, additionality means an increase in ODA that is not redirected from social sector programmes, such as health or education. In 2006, both Aid for Trade and aid to social sector

programmes increased in volume. Assuming that the scaling up of total ODA will materialise, calculations by the OECD indicate that Aid for Trade could reach USD 30 billion in 2010 (based on a stable relative Aid for Trade share in total ODA), while a doubling of ODA volume could result in an increase of USD 20 billion.



### Asia and Africa receive most aid for trade

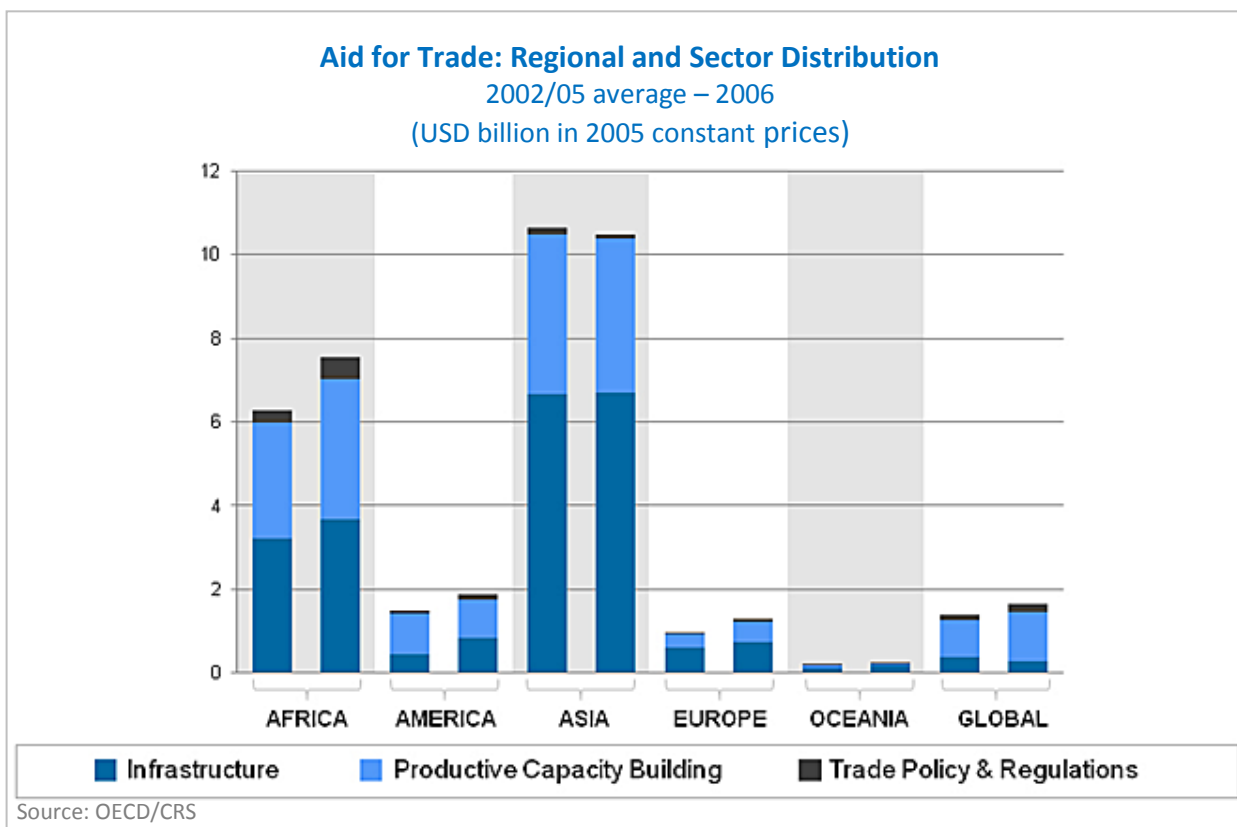
Asia and Africa continue to receive the largest volumes of Aid for Trade (respectively USD 10.5 billion and USD 7.5 billion). This comes as no surprise, as these continents are home to the highest concentrations of poor people. Asia's share in total Aid for Trade flows fell from 51% to 45.5% in 2006, although in volume terms the decline was only marginal. This was because flows to all other regions increased, most notably to Africa, where they grew by USD 1.3 billion; this raised Africa's share in total Aid for Trade to 32.7%.

A remarkable development in 2006 was the doubling of outlays for regional programmes, from USD 2 billion during the 2002-2005 baseline period to USD 4.2 billion. This doubling was spread more or less equally over all regions. On a global scale, this means that over 18% of all Aid for Trade is being disbursed through regional programmes. Commitments for global programmes also expanded in 2006, but at a more modest rate, *i.e.* 15% in real terms, reaching USD 1.6 billion.

### Economic infrastructure dominates aid flows

In terms of relative shares, Aid for Trade categories are fairly balanced between regions and income groups. Given the typically large size of economic infrastructure projects, aid to support these programmes naturally dominates overall Aid for Trade flows, particularly in Asia. In 2006, aid to economic

infrastructure reached USD 12.2 billion, representing an 8.6% growth in real terms. Activities to enhance productive capacity, including trade development, reached USD 9.7 billion, representing an increase of almost USD 1 billion. Aid to finance technical assistance programmes aimed at deepening understanding of trade policy and trade policy regulations increased almost 60%, *i.e.* almost USD 1 billion. Most of this growth took place in the least developed countries of sub-Saharan Africa.

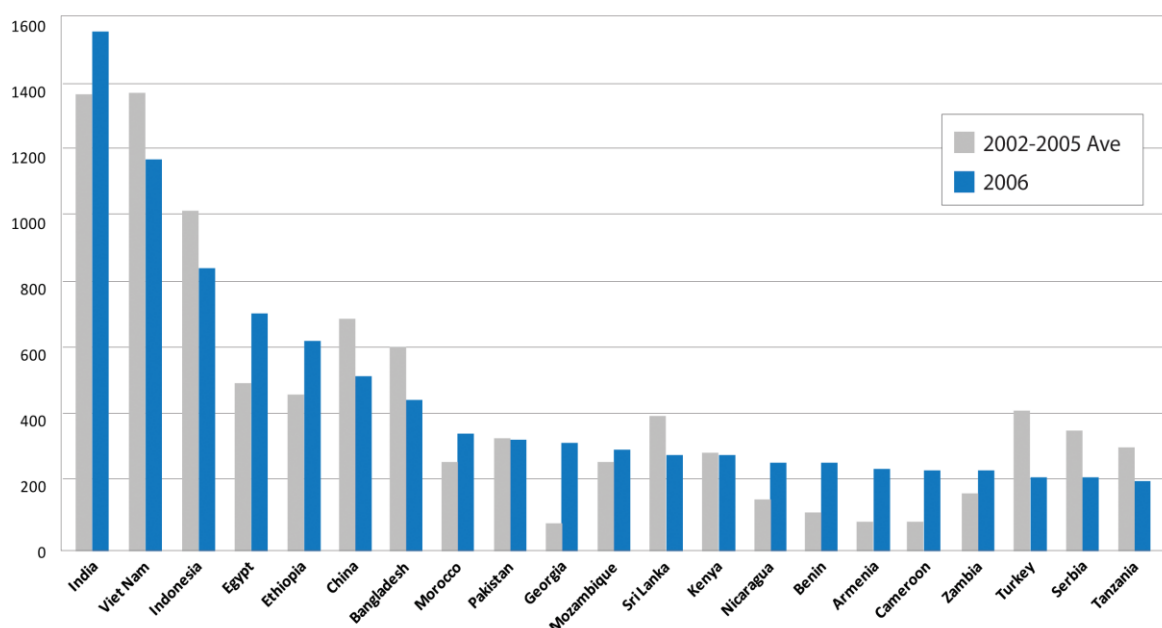


### Populous countries are the main recipients

In 2006, the top ten Aid for Trade partner countries received 35% of total Aid for Trade flows.<sup>1</sup> This comes as no surprise. All top ten recipients are developing economies and are also among the largest recipients of total ODA flows. Looking at the distribution of Aid for Trade *per capita* provides a completely different picture. It shows that small vulnerable economies receive around USD 100 in Aid for Trade *per capita*. These amounts are evidently much more modest for the top recipients in volume terms, *i.e.* USD 1.4 for India and half a dollar for China.

The distribution has remained relatively stable between baseline period and 2006, although China and Bangladesh switched places with Egypt and Ethiopia, while Georgia also moved in to the top ten slot replacing Sri Lanka.

\* Afghanistan and Iraq have been omitted from the analyses. This does not imply that aid to those countries is not trade-related. It is however driven by very specific circumstances.

### Is Aid for Trade working?

The Aid for Trade Initiative has so far been a success in encouraging additional financial resources. However, the outlook for 2008 is distinctly less positive. Three crises, *e.g.* the credit crisis, rising food prices, and the failure to conclude the Doha Development Agenda have distinctly worsened the global economic outlook. No doubt, they will also affect the prospects for aid for trade. Maintaining the momentum requires even more than before the explicit prioritisation of trade-related needs in the dialogue between donors and partners about national development strategies.

### NOTES

- The WTO Task Force definition of aid for trade covers a broad set of expenditure categories as indications of donor activities which impact on partner countries' trade capacities. The OECD Creditor Reporting System (CRS) was recognised as the best data source for tracking aid for trade flows at global level, but it cannot provide data that match exactly all the above categories. Instead, it offers proxy measures for key categories.
