## **1. The Chilean Experience in National Accounts and Base Year Compilations**

Estimates of National Accounts began in Chile during the 1940s, in the CORFO (Corporation for the Promotion of Production), the institution in charge of developing the national accounts series from 1940 to 1964. In 1965, the responsibility fell on ODEPLAN (National Planning Office), where the national accounts for the period 1960 to 1980 were developed. Later, in 1982, the task of developing the national accounts was passed on to the Central Bank of Chile, as it is established in its Basic Constitutional Act.

Regarding benchmark compilations, five studies have been developed in Chile to compile national accounts base years. These studies determined the supply-and-use tables and/or input-output matrices. The first study was developed in 1962, and was broadly based on the international recommendations that were in force at the time (SNA 1953; UIIC rev.1). Transaction valuation was performed at user prices and was presented in a breakdown of 54 activities. As for the price basis, a base year was established for measurements at constant prices, and this basis was preserved throughout the following benchmark compilations, including the last compilation corresponding to year 2003.

Sixty-eight activities, including bank allocations, were recognized in the matrix of the 1977 base year, which was based on recommendations from the SNA 1968, and in the UIIC Rev. 2. classification. It was valued at user prices.

The Input-output for 1986 included a distinction between activity branches and products, whereby 75 activities/products were defined. Tables were valued at basic producer and user prices, and additional output–input matrices were presented by destination activity (product/activity). The adopted conceptual framework corresponded largely to the SNA 1993, which at the time was being developed by the corresponding international organisms, especially regarding VAT treatment and secondary productions.

The study for the 1996 input-output matrix defined 73 activities and products, and was based on the SNA 1993 and the UIIC Rev. 3. In addition, an integrated national accounts system was prepared, which took into consideration production accounts, income and expenditure, and accumulation by institutional sectors in an integrated set of accounts.

Finally, the 2003 benchmark compilation presents the above mentioned characteristics of the 1996 benchmark, and its main purpose was to revise the values of the macroeconomic aggregates that were estimated on the basis of the 1996 benchmark observations for 2003. The methodological changes included in this new benchmark compilation are basically of two kinds: changes in the classifiers and changes in the estimation methodology. The former modifies the way that the activities and products are grouped, whereas the latter affects the estimates itself, as is the case of a shift from net accounting to gross accounting in mining and electricity. Progress has also been made in the methodologies and application of the SNA 1993, such as the measurement of the natural growth of forest plantations and the treatment of fish nurseries (aquaculture).

## **2. NA Compilation in the Central Bank of Chile**

### **2.1. Institutional and Organizational Framework**

The Organic Law of the CBCh (1989) confers upon it the function of timely compiling and publishing the main national macroeconomic statistics, including those relating to monetary and exchange rate policies, balance of payments and national accounts.

The National Statistics Bureau, on the other hand, compiles a wide range of sector statistics on production, sales, consumption, employment and prices. Among the latter, the consumer price, producer price, wage, and labor cost indexes are worth mentioning.

In the compilation of national accounts, the Bank strongly relies on the collection of basic statistics by the National Statistics Bureau (NSB). For this purpose, there is an agreement between both institutions for the provision of such information. Other relevant external sources of basic information are the National Customs Service for foreign trade information; the Internal Revenue Service for tax records; and the Superintendence of Banks, Securities and Insurance, and of Pension Fund Administrators (AFPs), for information of financial nature.

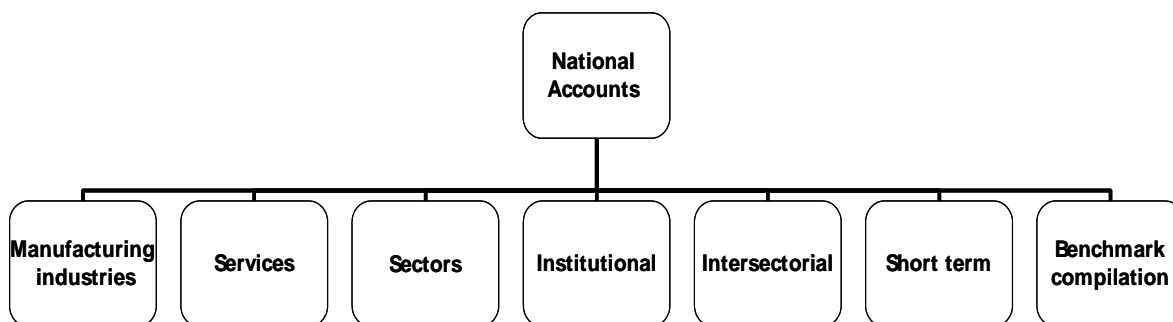
In Chile, the National Accounts (as well as the balance of payments, and monetary and financial statistics) are compiled and disseminated by the Statistical Information and Research Management (GIIE). In the particular case of National Accounts, the compiling unit within the GIIE is the National Accounts Department (DCN).

The DCN is a unit comprised of 35 persons, the majority of which are economists. According to the IMF (2007) these resources are adequate in terms of number and professional qualification.

A training policy is in place, which allows the department’s professionals to participate in courses offered by national and international organizations, and internships in internationally renowned agencies are also promoted, enabling the exchange of knowledge and experiences in best practices.

The organizational structure of the National Accounts Department is flexible and is at present organized in seven working groups, which participate in three areas or specific processes within the unit: follow-up of the compilation process; consistency, and benchmark compilation.

The “Manufacturing Industries”, “Services” and “Sectors” groups compile their respective accounts for the benchmark, annual, quarterly and monthly compilations. A fourth group involved in the compilation process is the Institutional team, which is in charge of the compilation of institutional and financial accounts.

Two additional working groups are involved in the consistency process: the “Intersectorial” and “Short – term” groups. The former is in charge of the conciliation of annual supply-and-use tables, whereas the short-term group is involved in the conciliation of the quarterly information, as well as the compilation of the IMACEC (Index of Monthly Economic Activity).

Finally, the seventh group is in charge of the planning, coordination and execution of benchmark compilations.

## 2.2. Conceptual Framework

The compilation of Chile's national accounts, as well as the production, valuation and asset delimitation criteria, are in line with the recommendations of the SNA 1993. In Chile, it is a practice to compile the national accounts at constant prices of a fixed base year. The year currently used is 2003.

National classifications of economic activities and products are consistent with the classifications that are in force worldwide. Specifically, the Uniform International Industrial Classification (UIIC Rev.3) is used for activities, and the Central Product Classification (CPC) guidelines are followed in the case of products. The Classification of the Functions of Government (COFOG) and the Classification of Individual Consumption by Purpose (COICOP) are in the implementation phase.

## 2.3. Main Products

The DCN performs follow-up compilations at different frequencies: benchmark compilation, annual production and institutional accounts, quarterly accounts and the IMACEC. In addition, regional accounts are prepared in conformity with the current guidelines.

2.3.1. Benchmark Compilation: The main objective of the benchmark compilation is to obtain better and more comprehensive estimates of the components of the national accounts against those obtained for the follow-up years. Moreover, it is used to establish a new price basis for the measurement of the national economy, and it allows for the preparation of an input-output matrix, which at the same time enables the analysis of structural economical changes.

The Benchmark Compilation is the most expensive compilation in terms of financial resources, insofar as it requires the implementation of more comprehensive data collection and analysis strategies compared to the follow-up process, particularly for certain activity sectors where the usual availability of information is incomplete and of limited quality.

The last Benchmark Compilation dates to the year 2003 and, as mentioned earlier, was the fifth compilation ever made in Chilean history. It must be also mentioned that the number of years between benchmark compilations was reduced from ten (1986-1996) to seven years (1996-2003). This period is expected to be further reduced to 5 years, having already defined year 2008 as the next base year for national accounts.

The results of the 2003 Benchmark Compilation were obtained from different projects worked out at different working groups: activities<sup>1</sup>, institutional<sup>2</sup> and intersectorial<sup>3</sup>. Regarding the real variables, the information from these projects was grouped in supply-and-use tables, which produced a system of 73 activities and 73 products<sup>4</sup>. The 2003 Input-Output Matrix was derived from these results.

2.3.2. Annual National Accounts: In Chile, the following accounts are prepared on an annual basis: Gross Domestic Product and Expenditure Components, the Disposable National Income, Integrated Accounts by institutional sector, which include the Current Accounts and Accumulation Accounts, i.e., Capital Account and Financial Account, up to the net loan, plus the foreign trade accounts. The sectors for which the

integrated accounts are prepared are the financial institutions, non – financial companies, general government, households and Non-profit Institutions Serving Households.

The national accounts for the GDP include estimates for 73 activity branches and products. Regarding expenditure, the following components are included: final private consumption expenditure; final consumption expenditure by Government; gross fixed capital formation; changes in stocks and exports, and imports of goods and services.

The sources of information and methods vary according to the economical activities. Overall, the sources are related to administrative records, economical surveys -whether executed by the CBCh or by the NSB-, financial statements, yearbooks, statistical reports and various figures. In order to make estimates at constant prices, the double deflation method is used to estimate approximately 45% of the national GDP.

The output approach is largely used to estimate the GDP by economical activity (industries).

The output accounts of the agricultural activity are prepared using output estimates based on the cropped area for the different products, which is information that the NSB provides. In the case of fruticulture, estimates are based on the estimated output by species. In the case of livestock farming, they are estimated mostly according to cattle, poultry and pig outputs, and milk production. As for forestry, information from administrative records is used. Annual costs, on the other hand, are estimated by upgrading the studies of benchmark years.

Estimates for the fishing activity are based on the output data of the administrative records and surveys.

Activities with a higher concentration of establishments, such as Mining, Electricity, Gas, Water and Communications, are largely estimated through surveys and direct information from the companies.

Output estimates for the Manufacturing Industry, Trade, Personal Services, and Business Services are estimated using information from the structural surveys of the NSB, as well as tax related statistics. As for Education and Health, there is background information available from public institutions related with these services.

Estimates for the Construction activity are based on information on building permits and surveys of civil engineering expenditure incurred by both public and private agents. As for Dwelling, the estimates are based on the growth in housing stock.

The Transportation sector uses a combination of sources. On the one hand, it uses direct data from surveys (air transport, railroad transport, maritime transport, and related), and on the other, activities such as ground cargo transport and public transport are estimated using indirect methods.

Output for the Financial sector is estimated using direct information from the Superintendence of Banks and the Superintendence of Securities and Insurance. In the case of the Banking sector, the estimate includes both the real output and the imputed output (FISIM, financial intermediation services indirectly measured).

In the case of the Public Administration, output and costs are estimated using budgetary information from the different agencies of the Government sector. The added value is mostly related with remunerations and allocations for consumption of fixed capital.

Finally, the VAT at current prices is estimated using direct information from public finances, as well as import duties. Regarding the values at constant prices, the current rates of the base year are applied by type of product.

Regarding the expenditure of the gross domestic product, there is a direct measure of government final consumption and exports and imports of goods and services. In the case of the final consumption expenditure by Government, the information derives from budget records of the public sector, while the information used to estimate the imports and exports of goods and services comes from the National Customs Service. In the gross formation of fixed capital, the component of construction derives from the estimates made for the corresponding activity, both in building and in civil engineering. Estimates of investment in machinery and equipment, the largest component of which is imported, come from Customs and Balance of Payments, as well as from manufacturing industry output.

Private consumption includes the Household final consumption expenditure and the expenditure of Private Nonprofit Institutions Serving Households.

The estimate is largely based on sales indicators of consumer goods and on the commodity flow method; an adjustment is also included for direct purchases abroad by resident households and in the domestic market by non-resident households.

Changes in stock are estimated during the estimation process of the flow of goods, as a complement of the direct information gathered from activities with background information on this variable.

Supply-and-Use Tables (SU-Tables) are used for conciliating the different variables of the accounts, in relation to both the GDP origin and expenditure. Both at current and constant prices.

In order to give an order of magnitude of Chile's main aggregates tables 1 and 2 below present GDP shares by sectors of origin and by expenditure components for 2003.

In relation to the dissemination of the Output Accounts, these are presented for 26 activity branches or industries and 26 products.

Temporally consistent aggregated figures are available from 1986 onwards.

2.3.3. Quarterly National Accounts: The Quarterly National Accounts are prepared using output indicators of the economic activities, which allow the extrapolation of different components of the last Benchmark Compilation, using a method of fixed coefficients (Intermediate Consumption on Gross Output Value) for the measurement at constant prices.

Measurements at current prices are done by applying the price indexes of the different products. These quarterly results are adjusted to the national accounts through the method of temporal disaggregation proposed by Denton. As for the quarterly supply-and-use tables, these are conciliated at a level of 33 products/activities and are published for 22 activities.

There is timely and good quality quarterly information available, particularly for the following activities: Mining, Electricity, Gas and Water, Industry, Government, and Commerce. This information is derived either from quarterly surveys or administrative records, including foreign trade and tax related statistics.

As for expenditure, the basic sources of information are connected with consumption and sales indicators; imported machinery; registry of engineering works, inventory surveys and foreign trade data. The consistency of these variables is ensured in the supply-and-use table, allowing for the consistency between the GDP expenditure components and the supply at product level.

Estimates of the quarterly GDP by activity of origin and expenditure components are available for the period 1980 onward in the different bases of Chile's National Accounts.

Regarding the temporally consistent quarterly accounts, there are series at constant prices since 1986, and at current prices since 1990.

2.3.4. IMACEC (Monthly Index of Economic Activity): This is a synthetic indicator of the evolution of the monthly economic activity, which is compiled at constant prices. It is a Proxy variable for the changes in GDP, as there is no information for estimating a monthly output account.

This indicator is estimated through an accounting approach, adopting a Laspeyres volume index that results from the integration of the monthly output indexes of the relevant industries, according to the structure of the base year 2003.

The IMACEC is compiled at 73 branches of activity. However, it is published in an aggregated form because it is only representative at this level.

There are temporally consistent series from 1986 on a monthly basis. The original series, seasonally adjusted series and the trend cycle are published. The seasonal adjustment is estimated using the X-12 ARIMA.

2.3.5. Regional Accounts: The regional GDP is measured using an output approach rather than an expenditure approach. The regional GDP is estimated at constant prices using the last benchmark year (2003) as a base. The base series 2003 related with the Regional Gross Domestic Product (RGDP), has a geographic coverage of thirteen regions according to the current political and administrative division.

The coverage of the RGDP includes the added values of the activities and bank allocations, since the regional estimate of import duties (ID), or the value added tax (VAT) are not available due to the lack of records required to identify the intermediate and final users per region that participate in these flows.

The RGDP is prepared using accounting and tax related information, direct surveys to producers and general statistical sources. The output approach is used to estimate the RGDP. This approach consists in estimating, for the resident establishments in each region, the Added Value (VA) as the difference between the Regional Output Gross Value (ROGV) at producer prices, and its Intermediate Consumption (IC), at user prices. In determining these variables, care is taken to respect the regional prices and quantities, aiming to keep a RVA/RGDP relation that is the most representative as possible of the product generated in the region.

In the estimation of the RVA of the following years of the series, the RVA of the base year is extrapolated by regional quantum indexes for the activities or sub activities, groups, companies or products considered in the estimates.

The resulting regional added values are adjusted to the nationwide total, trying not to change the rate of the indicator of activity and guarding that the effect on the change of the relative regional positions be as insignificant as possible.

There are estimates for real regional GDP series since 1960 in the different price bases of the national accounts.

## **2.4. Dissemination and Revision Policy**

There is a public revision policy with specific dates that are consistent with the quarterly and annual publications. In the framework of this policy, preliminary data are identified and a pre-announced revision schedule is published. In addition, revision documents are published when required. The table below

presents the general guidelines, by product, of the dissemination policy for the National Accounts of the CBCh.

Product	Dissemination
National Accounts	Three versions are published: preliminary, provisional and revised. Publication date is March of every year.
Institutional Accounts	They are published in March of every year with a one-year lag.
Quarterly GDP	They are published 53 days after the closing of the benchmark quarter.
IMACEC	It is published 35 days after the closing of the benchmark month.
Regional GDP	It is published with a two-year lag, by region and type of economic activity.

### 3. International Assessment

International organizations have recently performed two assessments of the statistics prepared by the National Accounts Department. The first of these assessments was developed in January 2006 with the purpose of evaluating the works developed in the framework of the Benchmark Compilation 2003, as well as the work strategy that was implemented.

This report was structured under the guidelines of the Data Quality Assessment Framework (DQAF), which is based on the evaluation methodology of the Report on the Observance of Standards and Codes (ROSOC).

The result of this study was a largely positive assessment, with some minor observations regarding specific treatments, which translated into recommendations that will be implemented in the upcoming change of base. Some of these recommendations included the improvement in the measurement of the Dwelling activity, the incorporation of the natural growth of agricultural crops, and the measurement or re-estimation of own-account production of computer software.

The second international assessment was developed throughout the second half of the current year, 2007. Its objective was to provide a report on the observance of standards and codes in macroeconomic statistics (ROSC-Data Module). Like the previous IMF mission, this mission considered the IMF's assessment framework (DQAF).

The IMF's assessment was positive, and established that "the degree of progress of the Chilean national accounts is higher than that of emerging economies, and lower than that of the more advanced economies". One of the main recommendations was to establish user consultancy mechanisms; to advance in the implementation of the SNA 1993; to improve the quality of source data; and to enhance the retropolation techniques in use.

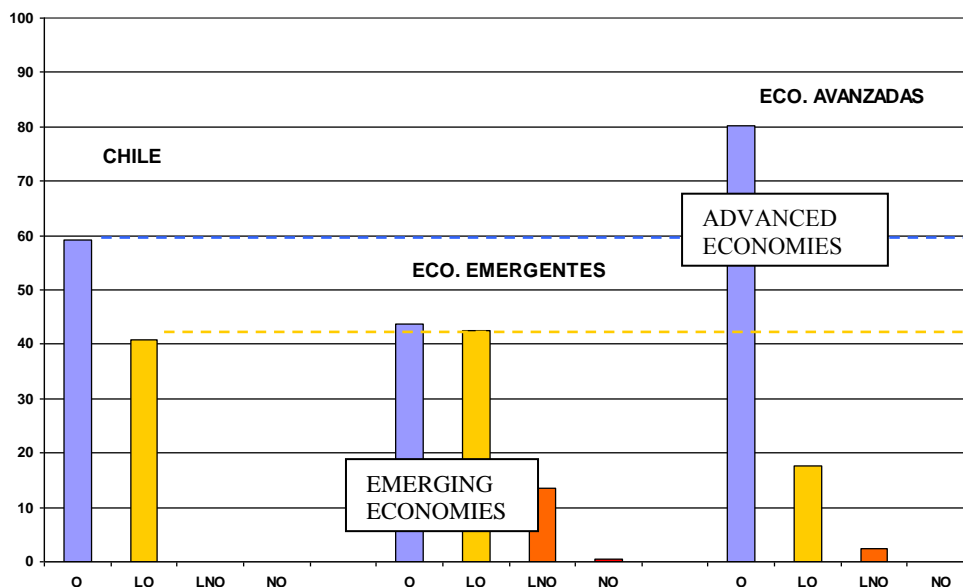
In relation with the first recommendation, it was suggested that regular consultations with information users be initiated as a means of improving the usefulness of statistics. In this regard, it was suggested that the name of the person responsible for each subject be published.

Regarding the implementation of SNA 1993, and given the importance of the mining and agricultural activities within Chile's economy, it was suggested that the agricultural work-in-progress and the treatment of mineral exploration be incorporated.

In order to enhance the quality of source data, the IMF proposed a more intensive exploitation of employment records. Finally, in regards to retropolation techniques, it was proposed that the historical series be reconstructed as far back as reasonably possible, with at least five years of retropolation.

The following chart and tables present a summary of the IMF's assessment.<sup>5</sup>

#### **4. Future Developments**

Some actions are in development while others are planned to be implemented in the next Benchmark Compilation 2008.

Actions from the first group include:

- Benchmark Compilation 2008, currently in the stage of scheduling and initiation of projects.
- Implementation of quarterly financial accounts.
- Assessment of statistical methods for the retropolation of series.
- Revision and extension of inventory surveys.
- Creation of user contact points to answer questions.

Some of the actions scheduled to be developed during the next Benchmark Compilation 2008, include:

- Enhancement of the SNA 1993 application. For example, natural growth of agricultural crops; mining exploration and measurement of own-account production of computer software.
- Assessment of the reclassification of some mining products, from mining industry to manufacturing industry.
- Greater openness in the processing and dissemination of products and activities.
- Assessment of the preparation of national accounts on a linked basis.
- Enhance joint works with the NSB, especially in regard to the collection of structural surveys, questionnaire design and data validation for national accounts.
