OECD Co-operation with Non-Members*



Russian Federation

The OECD has co-operated with the Russian Federation since 1992. The Russia Programme is the largest for any non-Member and has covered activities ranging from five Economic Surveys of the Russian Federation between 1995 and 2004, to seminal policy reviews of Russian education, agriculture, environment, investment, innovation policy, social policy, human resource development, science and technology and corporate governance.

Russian high officials have repeatedly acknowledged the Russian government's high regard for the OECD and its eagerness to reinforce co-operation, most recently during the Secretary-General's June 2004 meetings in Moscow with Prime Minister Fradkov and other Ministers. Russian Ministers regularly visit the OECD including participation in meetings.

Russia applied for OECD Membership in 1996. The Organisation responded by stating that Russia's accession was a shared ultimate goal. As a result, mechanisms were developed to strengthen the co-operation, including the establishment of a high-level Liaison Committee between the Russian Federation and the OECD. The sixth meeting of this Committee will take place in Moscow on 20 June 2005.

Russia participates in the work of 19 Committees and other bodies of the OECD. This breadth of participation is more than twice as large as that of the next best represented non-Member. Russian Ministers have participated in all Ministerial Council Meeting dialogue sessions with non-Members, except in 2002.

The year 2005 will see the completion of the flagship Regulatory Reform Review of the Russian Federation. The purpose of the review is to improve the foundations for the coherent and comprehensive design and implementation of regulatory reform policies. The review is horizontal in nature, including economic analysis and work on competition, trade, energy and railways.

SUMMARY:	Expansion and reform of tertiary education are major preoccupations in the development of education system policies and practices in many countries. It is a complex policy domain because policy must meet broad objectives – individual and societal, economic and cultural – in supporting the multiple missions of the system. Governments are major players in the sector even where there is a strong private sector, whether not-for-profit or profit. Governments are typically both providers and regulators. There is competition on the supply side and greater sophistication in demand. Fiscal pressures continue and how to fund growth and to manage supply are increasingly important questions. The market is becoming more international. Tertiary education is playing an increasing role in lifelong learning of adults alongside its more traditional role as the final phase of initial education for young people. SUMMARY: The proposed work will update the sectoral restrictiveness indexes for some of the countries that were already examined and that have experienced important changes since 2002 (e.g. Bulgaria and Romania) and present the indexes for some additional countries, namely China, Russia and selected non-Members. In addition, the study will seek to integrate into the restrictiveness indexes additional sector-specific measures as well as regulatory aspects such as transparency of existing regulations and the status of national regulatory agencies. Finally, separate indexes for the four modes of services supply will be developed at the sectoral level.

Output: one report that presents: (i) an update of existing sectoral indicators for countries that experienced significant regulatory changes since 2002 (e.g. Bulgaria and Romania); (ii) sector-specific and modal improvements of services barriers estimates applied to selected non-Member economies (e.g. China, Russia and selected non-Member economies) highlighting the differences between the old and new indexes.

SUMMARY: Exchange of information between tax administrations is the most effective way of combating international tax avoidance and evasion. The events will draw upon and associate non-Members closely with OECD work in this area, including *the OECD Model Agreement on Exchange of Information in Tax Matters*, and the OECD report *Improving Access to Bank Information for Tax Purposes*.

SUMMARY: On the responsibility of the Investment Committee, investment outreach programmes promote international investment for growth and sustainable development in non-Member economies, by advancing policy reform and international co-operation through OECD peer dialogue method. Launched in 2003, the OECD Initiative on Investment for Development, including work on a Policy Framework for Investment, provides an organising principle for these programmes.

Together with the annual Global Forum on International Investment and regional investment initiatives, OECD investment outreach comprises sustained co-operation with the Russian Federation, through peer dialogue building on the recommendation of the 2004 OECD Investment Policy Review of the country. Expected outcomes are: increased investment policy transparency and openness; enhanced contributions of responsible international business; better outcomes of investment agreements; and improved FDI statistics for policy making.

In pursuit of its investment outreach mandate, the Investment Committee develops partnerships with other OECD Committees, business and civil society stakeholders, the World Bank and other international organisations. Nine non-Members have adhered to the OECD Declaration on International Investment and Multinational Enterprises and the Committee encourages other non-Members to apply for adherence. SUMMARY:	<p>Non-Members account for an important share of OECD countries' exports and investment and promotion of a corruption-free climate in these countries is essential to the Anti-Bribery Convention signatories in their efforts to achieve a level playing field for international business. In 2005, the Anti-Corruption Division will continue to co-operate with non-Members in Asia-Pacific, Europe-Central Asia, Latin America, and Middle East and Africa in assessing their anti-corruption policies and implementing reforms.</p> <p>Bilateral relations between the Working Group on Bribery in International Business Transactions and the Russian Federation began with Russia's application, in 2000, to the "Convention on Combating Bribery of Foreign Public Officials in International Business Transactions". The 2005 bilateral Russia programme will contribute to furthering mutual understanding and to ensuring legislative progress by the Russian Federation towards the OECD standards of the Convention as well as improvements in Russia's implementation and enforcement capacity of domestic laws and regulations in line with international anti-bribery standards.</p>

SUMMARY: The outreach programme in the competition law and policy area provides capacity building and policy dialogue with economies in transition and world-wide. The aim is to support the development of effective, efficient competition law enforcement and competition-based regulation and structural reform leading to better economic performance.

The programme has extensive geographical coverage including Russia, China, South-East Asia, Latin America, the Western Balkans and other countries in Central and Eastern Europe. Regional Centres for Competition based on a partnership between OECD and the national competition authority operate in Seoul and in Budapest helping countries in the region develop effective competition rules and institutions. The annual meeting of the Global Forum on Competition brings together competition leaders from more than 60 countries around the world. Subject to additional grants.

EVENTS: The Russia programme, since the early 1990s the most important country programme in the competition area, includes a case discussion seminar in Rostov in the end of September 2005, and a judges' workshop in St. Petersburg on 11-14 October 2005. SUMMARY:	<p>OECD has developed a substantial programme of policy dialogue and capacity building to promote modern, open and sound insurance and private pensions systems in emerging markets and developing economies. This work has been developed on a global, regional and country basis, with support of substantial voluntary contributions notably from Japan and the International Pension Foundation.</p> <p>Analytical work will be undertaken on issues where emerging economies could benefit from the experience of the Insurance and Private Pensions Committee, and OECD good practices for regulation and market access. Issues of particular relevance to emerging economies, such as management of large-scale risks, private pensions or financial education, may also be included.</p> <p>Closer dialogue through expert meetings will be promoted with key insurance and private pensions markets; including Brazil, Russia, India, China and South Africa.</p> <p>Recent market and regulatory reforms in the private pensions and insurance sectors in Russia have reconfirmed the importance for OECD Member countries to develop a closer relationship with Russia. Russia has also expressed its willingness to be more involved in OECD work. Planned activities with Russia include the publication of reports dealing with (i) pension reform and insurance market and (ii) regulatory/supervisory reforms in Russia. SUMMARY:	<p><i>Regulatory Reform in Russia</i> - Regulatory issues have been identified as key to structural and institutional reforms. Priorities include improving the regulatory capacities of the public administration, developing more coherent relations between different levels of government, and reform of key infrastructure sectors such as railways and electricity. These issues emerge clearly from the analysis of regulatory capacity and macro-economic trends carried out in the regulatory review of Russia (2003-2005). This review highlighted the scope of administrative reorganisation in that country, the challenges of building institutional and human capacity needed to sustain a shift away from the legacy of a command economy, and the high costs of administrative burdens, a lack of transparency, and confusion about laws.</p>

The key topics for further study in 2005 which build on this assessment of Russia's problems and opportunities are: (i) multi-level governance, to describe decision-making at different levels and the wider governance consequences of changes in federal government, to analyse the impact of multi-level issues on trade, investment and regional development, and to explore the options for improving regulatory quality, co-operation and coherence; and (ii) design of agencies for infrastructure development, to examine progress made following the reorganisation of regulatory institutions in key sectors.

These topics will engage Russian decision-makers with OECD practices on priority issues for good governance and growth, and will provide OECD Member countries with a better understanding of the changes taking place in Russia as it copes simultaneously with administrative reorganisation on a vast scale and integration into the world economy.
