

Uganda - achieving gender equality results in a Local Government Development Programme

Uganda’s strong local government system is supported by bottom-up electoral, planning and budgeting processes. Local governments are required to meet basic criteria to access development grants, with an incentive framework that rewards good performance. When the gender equality policy was not satisfactorily translated into actions at the local levels, gender mainstreaming was included in the incentive framework which created a system and structure for collective ownership of gender equality.

| | <p>Diana Rivington, Director, Equality between Women and Men, CIDA CIDA's Framework for Assessing Gender Equality Results includes a tool to assess how core-funded partners are organised to deliver on gender equality results. Since 2005, CIDA has worked to produce baseline Gender Equality Institutional Assessments (GEIA) for all major core-funded partners. Draft GEIAs are validated in broad discussion with partner organisations. This should permit CIDA to measure whether there will change over time in the achievement of gender equality results.</p> <p>Sally Moyle, Gender Adviser, Australian Agency for International Development (AusAID) AusAID's 2007 gender equality policy asks that gender equality be integrated across the development assistance programme. It suggests a results framework within which each development activity within the Australian programme can begin to think about the gender equality results it can achieve. Programme managers are asked to measure gender equality results within their own programmes because gender equality is seen as integral to all good development. The policy suggests an analytical framework for integrating gender equality into each activity. The approach that AusAID has taken is ambitious but it can achieve strong results and we are beginning to see some good examples.
