

## Information about controls for transboundary movements of non-hazardous plastic waste

As of 1 January 2021, the *Decision of the Council on the Control of Transboundary Movements of Wastes Destined for Recovery Operations* ([OECD/LEGAL/0266](#)) stipulates that each OECD Member country retains its right to control non-hazardous plastic waste<sup>1</sup> in conformity with its domestic legislation and international law. Member countries agreed to inform the OECD Secretariat about their controls applied for non-hazardous plastic waste, as well as about any future changes of such controls, in a timely manner.

This document provides information on the controls as submitted by OECD Member countries as at 16 November 2021.

### Note:

- The information provided by the **European Union** applies to all of its 27 Member States. The information provided by the 27 Member States individually serves as additional information and identifies links to domestic resources.
- **Colombia** has become an Adherent to OECD/LEGAL/0266 with a specific timeframe for implementation. Therefore, it is currently not participating in the Decision's control system.

The Chief Inspectorate of Environmental Protection and Voivodship Inspectorates of Environmental Protection as administrative authorities cooperate with other services in fighting against illegal shipments of waste i.e. Border Guards, Customs Office, Road Transport Inspection which control road and maritime transports of waste. Also the police is involved when necessary. The abovementioned services monitor the documentation and verify shipped loads in comparison to the documents attached.</p> <p>All the definitions and criminal sanctions for illegal shipments of waste are stipulated in the Criminal Code of 6 June 1997, Chapter XXII titled as “Crimes against the environment” in Article 183. The Inspection of Environmental Protection reports the suspected crime to the prosecutor’s office and provides evidence on the case collected during their inspection. The Inspection of Environmental Protection has the power to fine the offenders or to submit a request to the competent court to obtain a judgement against the offenders.
