10 years after the financial crisis, Gabriela Ramos will outline how the crisis affected ordinary people in OECD countries, what the impact on society was, and how things need to change. She will outline the OECD's pioneering New Approaches to Economic Challenges initiative, which looks at the interconnected challenges we face, identifies the analytical and policy tools needed to understand them, and creates the narratives best able to convey them to policymakers.

This session will look at what OECD countries have learned from the recent spike in demand for international protection and how countries can be better prepared for the next surge. Systems were resilient although some responses could have certainly been better. Early warning systems, co-ordination across levels of government and internationally and interaction with other actors can help reinforce institutional capacity to respond. International co-operation can improve conditions for both integration and sustainable return. A number of specific integration programmes work for groups with vulnerabilities such as unaccompanied minors, very low-educated refugees.

Laws and regulations are essential. Their everyday effects are felt everywhere: building safety, reliable transport and safe drinking water to name just a few. But as policy makers better understand the importance of regulatory quality, the world has become more complex. The pace of technological changes and the unprecedented interconnectedness of economies leave governments unsure of what and how to regulate. The latest edition of the *Regulatory Policy Outlook* provides evidence of how 39 economies deal with the quality of their laws and regulations, highlights countries' good regulatory practices and identifies areas for improvement.
