


About netFWD

[RedEAmérica](#) is a thematic network of business foundations and companies with 70 members in 11 Latin American countries that invest private social resources in grassroots development. Its objective is to contribute to poverty reduction and to strengthen democracy in Latin America. RedEAmérica's approach, which inspires its members, seeks to help communities and its organizations to achieve a more dignified life, and to acquire collective capabilities, linkages (social capital), increase their voice, become protagonists of their own development and participate in guiding the destinies of their communities. RedEAmérica believes that this is the only way to contribute effectively to break out the poverty trap and the exclusion, and firmly believes that this is the private social investment most likely to bring up significant impact and long-term effects, which are sustainable in communities as well as in society. netFWD has become an official member of [World Wide Initiatives for Grantmaker support](#) (WINGS). Through our collaboration we will strengthen our common efforts on the following areas i) accountability and transparency in global philanthropy; ii) collection and standardization of data in philanthropy; iii) promote the exchange of knowledge and best practices; iv) netFWD's visibility and products' dissemination; and v) netFWD's participation in WINGS Forum 2014 as follow-up with the netFWD-UN-WINGS workshop (April 2013, New York) on post-2015.

Participation of netFWD in the East Africa Philanthropy Conference on 24-26 July in Mombasa, Kenya



netFWD was invited to join the [East Africa Philanthropy Conference](#), which is a key event designed to explore local innovative strategies developed to link social investment with social impact. The Conference will discuss the place of business in philanthropy' and 'the place of philanthropy in businesses. Through its ongoing work with the Enterprise Philanthropy Working Group and its study (see below), netFWD will contribute inputs to some of the underlying questions, ranging from whether these new changes and shifts are relevant to Africa? What roles do/can philanthropists and impact investors play in their efforts to alleviate poverty and bring about sustainable social change? What will create the shift from the traditional forms of philanthropy involving charitable contributions towards more strategic forms of philanthropy that leverage on unique corporate capabilities?

Follow up: High-Level Symposium “A renewed global partnership for development for a post-2015 era”



netFWD was invited and represented by the *Olusegun Obasanjo Foundation* at the [UN's High-Level Symposium “A renewed global partnership for development for a post-2015 era”](#) that took place in June in Addis Ababa, Ethiopia. Working towards developing a set of “joint commitments” from both foundations and governments on concrete ways to engage more strategically in development cooperation, netFWD conveyed key messages on behalf of the philanthropic sector, building on the outcomes from the netFWD-UN-WINGS workshop (April 2013, New York). Some of these messages included: i) Flexibility as key word for a renewed global partnership for development, building pragmatic and innovative partnerships (e.g. PPPs); ii) Enhanced coordination, both at the field level and at the global level, to reduce fragmentation and to allow for more systematic scaling up of successful efforts; iii) Focus on issues-based efforts, especially at the country level; iv) Better understanding of foundations’ comparative advantages (e.g. ability to take risks, to operate on longer timelines); v) Enhanced efforts to enhance accountability to beneficiaries AND governments as well as greater transparency through the sharing of data.

Foundations represented at the next Steering Committee meeting of the Global Partnership for Effective Development Co-operation (GPEDC)



Further to a letter from the Shell Foundation on behalf of netFWD to the three co-chairs of the [Global Partnership](#) (Armida Alisjahbana - Indonesia, Justine Greening - UK, Ngozi Okonjo-Iweala - Nigeria) to draw their attention on foundations’ interest to be more systematically associated to the work of the Steering Committee of the GPEDC, foundations have been granted an observer status at its next meeting, to be held on 25-26 July in Addis Adaba. In their response, the co-chairs specifically mentioned their “desire to see foundations and philanthropic organisations play a more active role in international dialogue on development co-operation, and in advancing the agenda forged in Busan”. netFWD will keep supporting foundations in their policy dialogue and outreach efforts in these high-level fora and looks forward to allowing foundations to play an increasingly tailored and impactful role in such partnerships.

The Report of the High-Level Panel of Eminent Persons on
the Post-2015 Development Agenda

The Report of the High-Level Panel on post-2015 clearly acknowledges the role of philanthropy for development, as well as its value added, stating that foundations can “innovate and be nimble and opportunistic, forming bridges between government bureaucracies, international institutions and the business and CSO sectors. Foundations and philanthropists can take risks, show that an idea works, and create new markets where none existed before. This can give governments and business the confidence to take the initiative and scale up successes” (p. 11). Through its strong involvement within the Global Partnership for Effective Development Co-operation (see above) and through its collaboration with the UN, netFWD has gained legitimacy and is prepared to channel foundations’ voice on the wider development debate. Article “Philanthropes, que faire de votre argent?”





Report “Shedding Light on Our Own Practice Lessons About the Impact and Effect of our Own behaviour”



“[Shedding Light on Our Own Practice Lessons About the Impact and Effect of our Own behaviour](#)” is a report prepared for the European Philanthropy Learning Initiative. It examines the assessment and learning practices of foundations across Europe and shows that foundations are establishing new relationships for learning in and among organisations. They are also developing new internal capacities and processes. It raises questions such as: Can changing how foundations work enhance what they achieve? If foundations adopt new or improved working practices can they fulfil their purpose even better? Add more value to the work they support? Share their experience more fully with other funders? Influence more profoundly the policy context in which they work? The report was supported by Adessium Foundation, FACT, Fondation Lombard Odier, Oak Foundation and Pears Foundation and built on interviews with 26 foundations.

GrantCraft Guide “Foundations in Europe Working Together”



Part of the GrantCraft Series, the guide “Foundations in Europe Working Together” shows that the practice of foundations in Europe is very diverse and the context in which they work may vary from country to country. This diversity enriches collaboration among funders in Europe, but it can also present challenges, particularly when foundations look to work together across borders.
