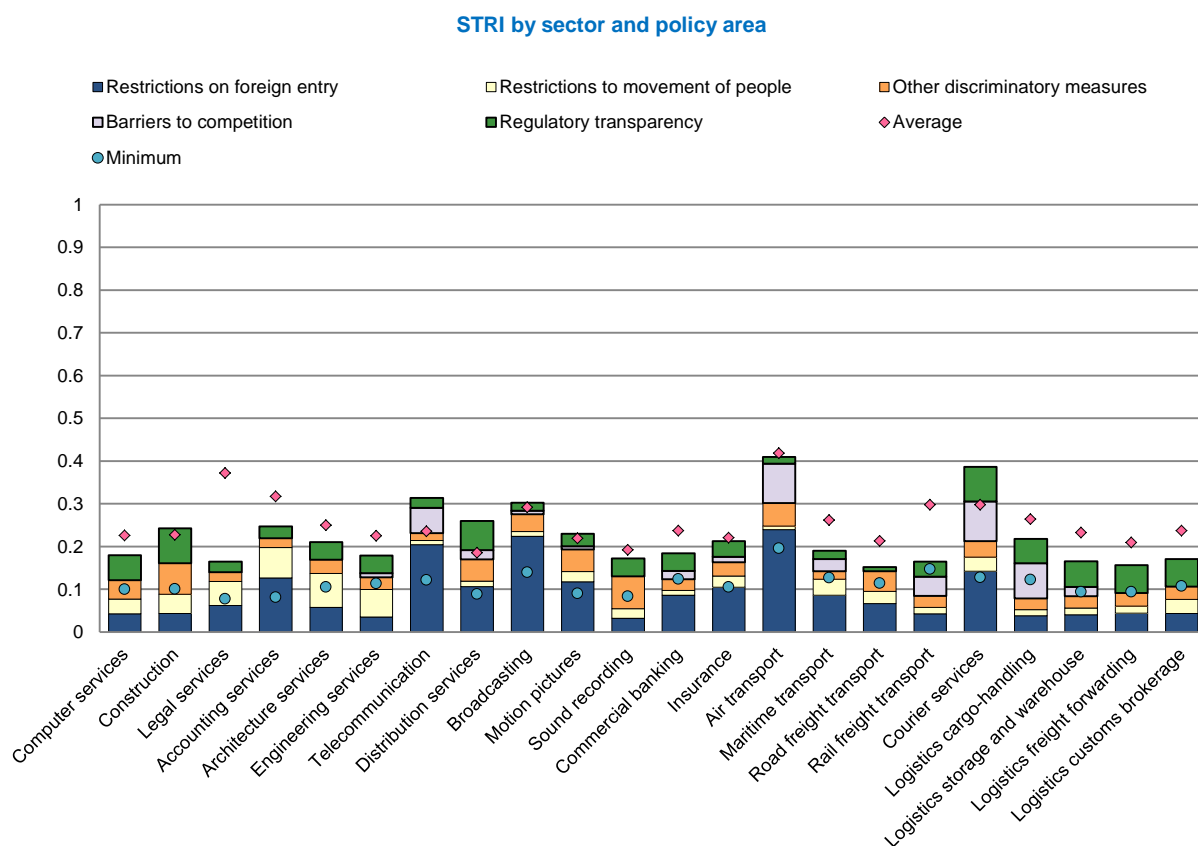


## OECD Services Trade Restrictiveness Index (STRI): Canada

Canada exported services worth USD 80 billion and its services import value was USD 99 billion in 2015. Tourism and travel are the largest exporting services while other business and travel are the largest importing sectors. Canada's score on the STRI in the 22 sectors is shown below, along with the average and the lowest score among the 44 countries included in the STRI database for each sector.



*Note:* The STRI indices take values between zero and one, one being the most restrictive. They are calculated on the basis of the STRI regulatory database which contains information on regulation for the 35 OECD Members, Brazil, China, Colombia, Costa Rica India, Indonesia, Lithuania, Russia and South Africa. The STRI database records measures on a Most Favoured Nations basis. Preferential trade agreements are not taken into account. Air transport and road freight cover only commercial establishment (with accompanying movement of people).

### Horizontal policy measures

Canada has a lower STRI score than the sample average in 16 out of 22 sectors. For those sectors to which the Investment Canada Act applies, investments are subject to screening, whereby foreign investors acquiring Canadian businesses that are valued above established thresholds must show likely net benefits to Canada. Canada also maintains labour market tests for workers seeking to provide services in the country on a temporary basis as contractual services suppliers or independent services suppliers. At least 25% of the board members of Canadian corporations must be Canadian residents or citizens. Rights of access to public procurement are limited to regional trade agreement partners and members of the WTO's Government Procurement Agreement. There is at least one major state-owned enterprise in broadcasting, postal and courier services, distribution and motion pictures.

### The sectors with the relatively lowest STRI scores

Legal services, rail freight and storage and warehouse (logistics) are the three sectors with the lowest score relative to the average in Canada. Storage and warehouse services are not subject to sector-specific restrictions, and regulation of rail freight transport does not create additional trade and foreign investment barriers. In legal services, a transparent and competency-based system is in place to recognise equivalent foreign law degrees. There are no nationality or residency requirements, and Canada's regime relating to foreign legal consultants also allows foreign lawyers to offer advisory services in their home country law, on any foreign law where they are licensed, as well as on international law. The majority of shares of domestic law firms must be owned by locally-licensed lawyers. Ownership limitations are accompanied by a requirement that the majority of board members and the managers of law firms must be locally licensed lawyers.

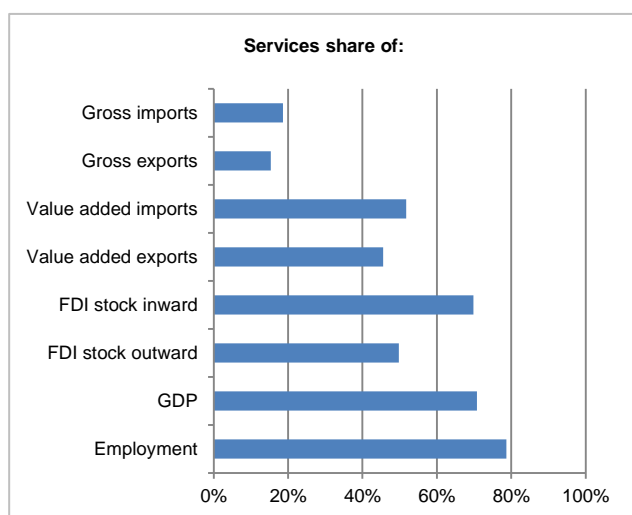
### The sectors with the relatively highest STRI scores

Telecommunications, distribution and courier services are the three sectors with the highest score relative to the average in Canada. The relatively high score for telecommunications is largely related to the investment regime, which maintains a cap of 20% foreign equity in large telecoms operators (the limits to foreign participation in providers holding less than a 10% market share have been removed). The law also requires that no less than 80% of board of directors' members in large telecoms providers be individual Canadians. The major sector-specific regulation in distribution services is a state monopoly for wholesale and retail sale of alcoholic beverages in Ontario, coupled with joint-venture requirements and restrictions on cross-border mergers and acquisitions in enterprises distributing books and magazines. Canada also maintains discriminatory access to certain settlement methods, acting as an impediment to e-commerce and multi-channel retailers. In postal and courier services Canada maintains a statutory monopoly for letters. Canada Post, a state-owned company, has a monopoly for letters of up to 50 grams. The Canadian regulatory regime for courier services outside the postal monopoly is effectively unregulated.

### Recent policy changes

No significant policy changes are recorded for the period 2015-16.

### Efficient services sectors matter



Services represent only 15% of Canada's gross exports, 45% of value added exports and 49% of outward FDI. These shares are below the average of the 44 countries included in the STRI database. Services also account for a notably higher share of employment than of GDP, showing that labour productivity is lower in services than in other sectors. Canada could further enhance the efficiency of its economy by prioritising reforms that increase competition in services sectors which are essential inputs in downstream industries.
