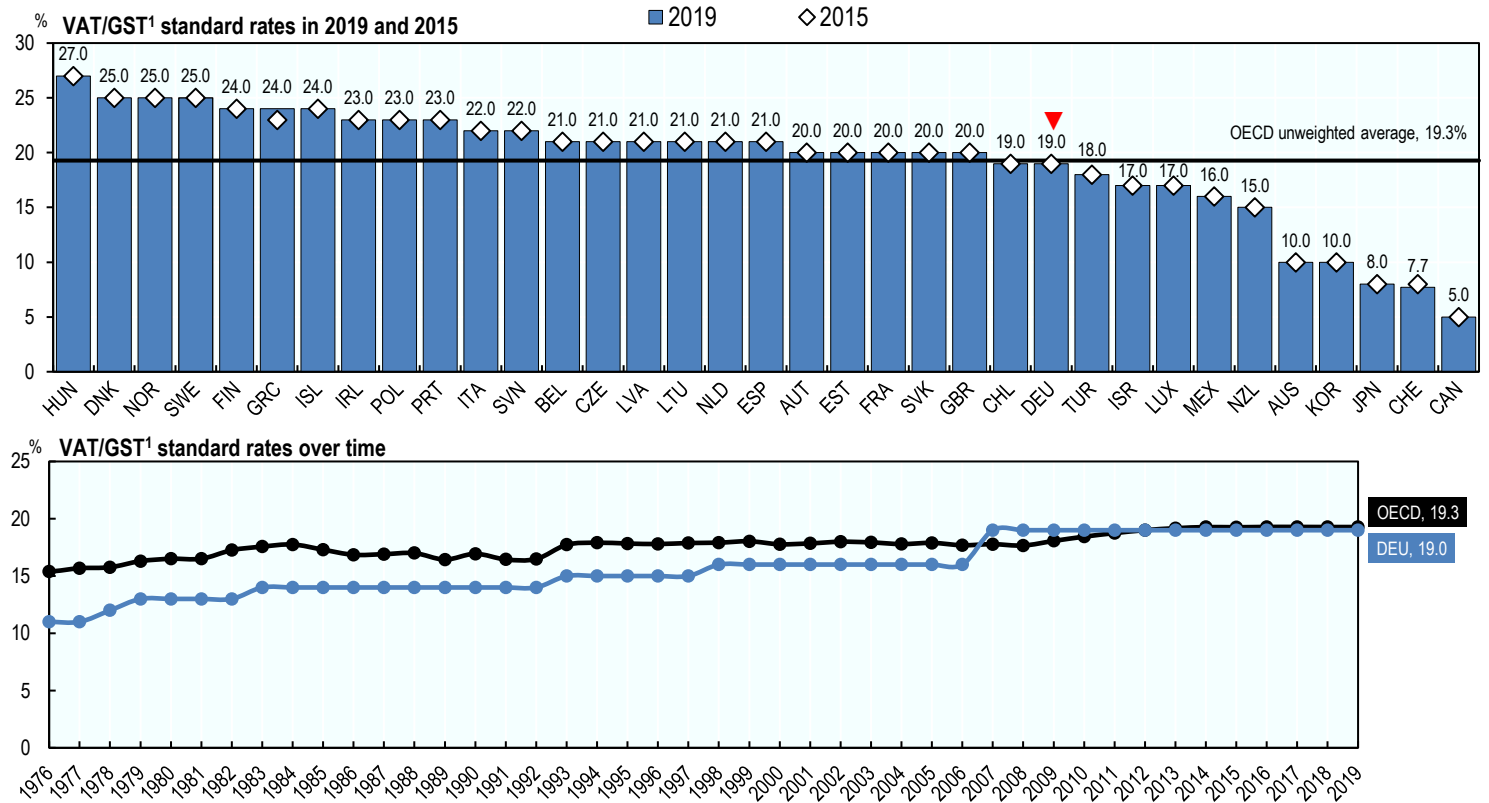


## Consumption Tax Trends\* - Germany

### VAT rate 2019

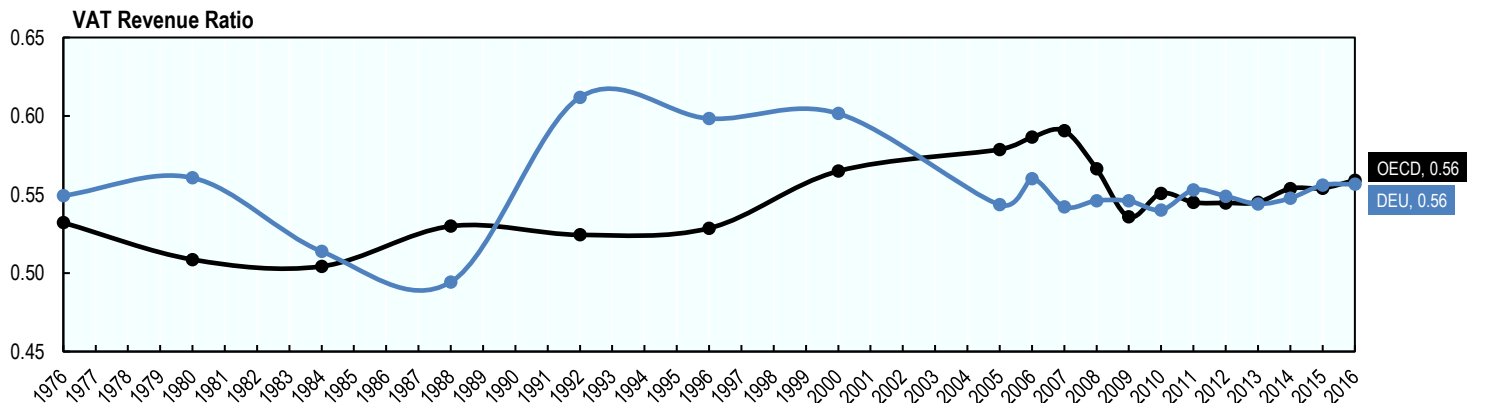
The German standard VAT rate is 19.0%, which is close to the OECD average. The average VAT/GST<sup>1</sup> standard rate in the OECD was 19.3% as of 1 January 2019. The previous standard VAT rate in Germany was 16% in 2006. It changed to the current level in 2007. Germany applies a reduced rate of 7% to a number of goods and services. VAT was introduced in Germany in 1968 at a standard rate of 11.0%. Since then the minimum and maximum standard rates have been at 11.0% and 19.0% respectively.

### VAT Revenue Ratio

The VAT Revenue Ratio (VRR) for Germany was 0.56 in 2016, below the OECD average of 0.56. The VRR is a measure of the revenue raising performance of a VAT system. A ratio of 1 would reflect a VAT system that applies a single VAT rate to a comprehensive base of all expenditure on goods and services consumed in an economy - with perfect enforcement of the tax. Relative to the pre-crisis level of 2007 (0.54), the German VRR position has increased by 0.02 percentage points. The German VRR increased from 0.55 in 2014 to 0.56 in 2016. The lowest VRR was recorded in the year 1988 at 0.49 and the highest level in 1992 at 0.61.

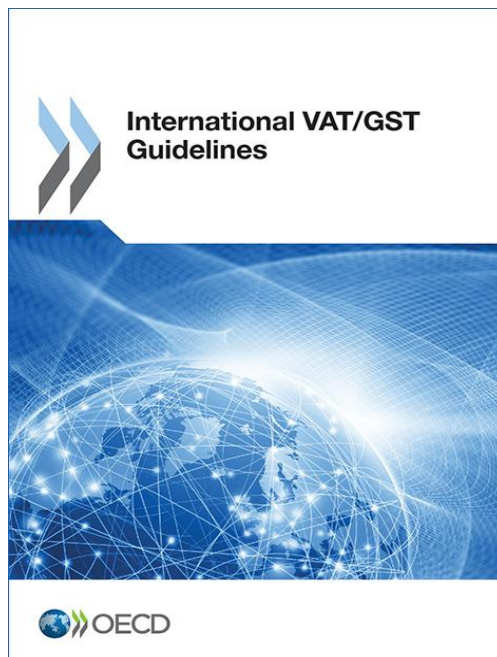

The International VAT/GST Guidelines now present a set of internationally agreed standards and recommended approaches to address the issues that arise from the uncoordinated application of national VAT systems in the context of international trade.

They focus in particular on trade in services and intangibles, which poses increasingly important challenges for the design and operation of VAT systems worldwide.

They notably include the recommended principles and mechanisms to address the challenges for the collection of VAT on cross-border sales of digital products that had been identified in the context of the OECD/G20 Project on Base and Erosion and Profit Shifting (the BEPS Project).
