What is the OECD Local Development Forum?

Created in 2004, the Forum has over thousands of members across 65 countries, comprising business leaders, start-ups, and social entrepreneurs as well as national policy makers, mayors and regional authorities.

It is a unique setting for the private and public sector to challenge assumptions, learn from each, and work together to forge practical solutions to today's economic and social challenges.

Objectives

Provides a **multi-stakeholder platform** to spotlight local trends shaping employment, entrepreneurship and social innovation policies.

Facilitates **global networking and knowledge-exchange** among policy makers and practitioners working at the regional and local level.

Identifies **policy innovation** through peer-to-peer learning and stakeholder engagement across public, private and non-profit sectors.

Provides a **consultation mechanism** to catalyse action from national governments on the need to “go local”.

The **last annual conference** brought together over hundreds of participants in Antwerp to identify **the "Right Skills, Rights Jobs, Right Places"**.

Previous events have taken place in **Porto, Prague, Venice, Manchester, Stockholm, Dublin, Berlin** and **Vienna**.

Within the OECD Centre for Entrepreneurship, SMEs, Regions, and Cities, the work of the Forum is overseen by the OECD LEED Directing Committee, a cross-cutting body bringing together ministries of employment and labour, economy and economic development from both OECD member and non-member countries.

Hosting Forum side events and workshops

Side events and workshops ensure deep knowledge-exchange along selected thematic topics within the Forum network. National, regional and local governments and associations can host Forum workshops, shaping the agenda and boosting their network and international exposure.

Benefits

Get international exposure and recognition. Hosting a Forum workshop is a unique opportunity to showcase the host country/region/city and market it as an investment destination to hundreds of practitioners, entrepreneurs and policy makers. Being associated with the OECD brand in all public documents and social media, the Host also boosts its international recognition;

Gain privileged access to a network of through leaders and change-makers, including ministers, mayors, innovators, and people delivering local programmes in their community;

Responsibilities

1. Co-manage the organisation of the event with the OECD team. A host project team works closely with the OECD team to define all organisational aspects linked to the gathering. Hosts are typically responsible for the identification of event venue and scenery, catering, interpretation, logistical support before and during the event;
2. Suggest session speakers and topics, identify local initiatives suitable for study visits and engage with local networks to attract a diverse range of stakeholders.

How to become a Host?

The Host is required to provide a voluntary contribution of EUR 150 000.
