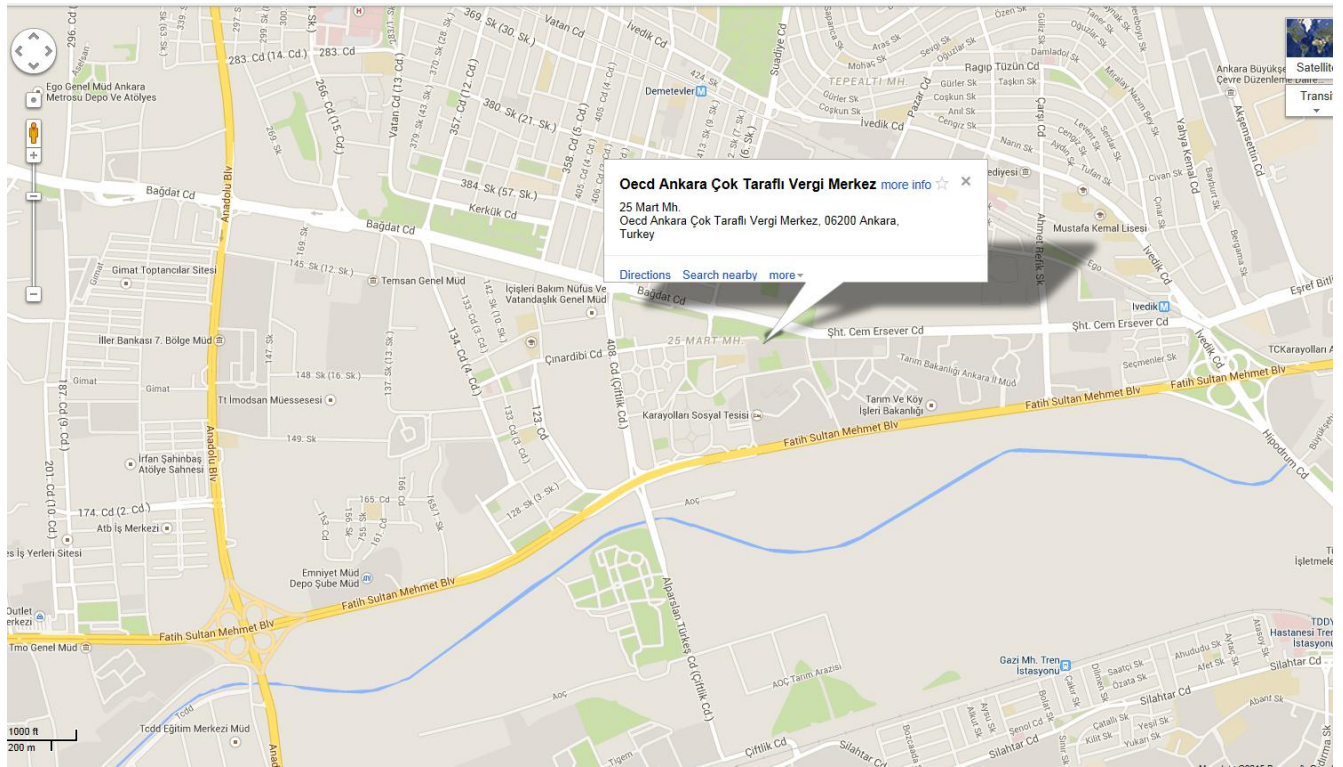

How to Get There

Please ensure that you meet the visa requirements before your departure to Türkiye by contacting the Turkish Embassy or Consulate in your country. The Turkish airports have foreign exchange facilities available. Usually, it is not possible to buy Turkish Lira (TL) in other countries before you arrive in Türkiye.

Upon arrival, a transportation service from Ankara Esenboğa Airport to the OECD Ankara MTC is provided normally for participants only (**not for experts**) free of charge by the Turkish Revenue Administration if travel details are sent to the fax number or e-mail address provided above. (**Please send us your flight details until last Friday 17:00 prior to the event to be picked up from the airport**).

Participants are kindly invited to meet Centre Staff at the **INTERNATIONAL ARRIVAL F gate**. Center staff will meet you **INSIDE** the F Door with a signboard with the text "OECD".

For those, who are not met by the Revenue Administration, the cheapest way is to take a shuttle bus (Ankara Shuttle www.ankaraair.com) from Esenboğa Airport to AŞTİ Bus Station and then take a taxi to the OECD Ankara MTC. The bus ride will cost 180 TL (as of September 2025) per person.

The exchange rate is approximately 1 USD = 41,47 TL, 1 EURO = 48,80 TL (September 2025). The Turkish airports have foreign exchange facilities available. It should be noted that the currency rates may be expensive relative to the exchange offices at the city.

A taxi from AŞTİ Bus Station to the OECD Ankara MTC will cost approximately 240.00 TL. Please show the taxi driver the address set out above and the attached map. The taxi, directly from the airport to the OECD Ankara MTC, will cost approximately 1100.00 TL.

It is not necessary to tip.

After the completion of the event, transportation service from the Ankara MTC to the Esenboğa Airport will be provided by the Turkish Revenue Administration for participants free of charge.

Accommodations and Meals

Accommodation for both experts and participants is provided free of charge by the Revenue Administration at the MTC from Sunday to Saturday. Meals, including breakfast, lunch, and dinner, are also provided free of charge by the Revenue Administration, but only from Monday to Friday.

All experts and participants will be accommodated free of charge at the OECD Ankara Multilateral Tax Centre (which is also used for training of tax officials of the Turkish Revenue Administration). This provides the maximum opportunity for interaction and dialogue between experts and participants and flexibility in relation to the development of the event.

When you arrive at the Ankara MTC, please identify yourself by showing your passport. The receptionist will give you the key for your room after registration.

Other Facilities and Support Staff

There are staff members in the Centre to help you during the event with sufficient knowledge of English.

The staff can be found in the OECD office on the first floor (the same floor where the OECD conference room is located). The conference room is equipped with two computers and two projectors giving lecturers the opportunity to make presentations in English and Russian as well as audio-interpretation equipment for simultaneous interpretation. A technician is available on site for any technical problem that may arise during the event. Two additional rooms are also available for group discussion or case studies.

Social Events and Touring Ankara

A dinner will be held usually on Wednesday night of the course. On Wednesday afternoon, participants will go on a city tour. On Monday, Tuesday and Thursday evenings, visits will also be organized to certain places of Ankara. These tours include sightseeing of some cultural and historical places, visiting the city center and well-known shopping areas in Ankara.

Participants, experts and some staff members of the Revenue Administration are invited to this event. As you will see, this provides a good opportunity for the participants and experts to get to know each other on a social level and considerably enhances the discussions on subsequent days.
