The four-step approach: the basic adaptation planning process

- The systematic process deals with all questions relevant for planning adaptation.
- Going one step at a time avoids mental blocks due to the over-complex challenge.

Four steps:

1. Assess vulnerability
- 2. Identify adaptation options**
3. Select adaptation measures
4. Develop an M&E framework





Rationale

Objective

- Second step of planning adaptation
- Collect the broadest possible range of adaptation options

Importance

- Climate change adaptation is new and requires out-of-the-box-thinking
- Easier said than done → brainstorming
