#### **Seminar session 2: Risk mitigation, bundling of projects and Environmental, Social and Governance (ESG) risk assessment in infrastructure financing for climate mitigation, adaptation and resilience**

Despite growing need for infrastructure investment, especially in projects that can enable a transition to a smarter, low-carbon economy, long-term investor interest in the sector remains untapped.
