Purpose of the workshop

The OECD Joint Working Party on Trade and Environment (JWPTE) is currently examining the various linkages between the environment and regional trade agreements (RTAs). It has recently finalised a report looking at countries' experience with negotiating and implementing provisions on environment in RTAs. The report will be published as a book and distributed at the workshop. It is also available on the workshop webpage.

The purpose of this workshop is to disseminate the findings of the report and share countries' experience in dealing with environmental issues in RTAs – with a particular focus on FTA negotiations in Asia. The workshop also aims to discuss new developments on environmental issues in RTAs and to collect experts' input for the development of a checklist on environment for RTA negotiators.

Experts and participants

This workshop is organised under the aegis of the OECD Joint Working Party on Trade and Environment (JWPTE). The workshop is open to representatives from OECD countries, observers to the JWPTE as well as experts from non-OECD countries and non-governmental organisations.

Funding of non-OECD participants' travel has been possible thanks to voluntary contributions from Japan and New Zealand.

Background material and discussion

All participants will receive a copy of the OECD book on Environment and Regional Trade Agreements, which will serve as background document for the workshop.

The workshop intends to facilitate dialogue among experts from OECD and non-OECD countries. Therefore, each session will only have few formal presentations, which will be kept short (10 minutes) in order to allow ample time for interventions from other participants. Each participant will intervene in his/her personal capacity.

Japanese-English interpretation will be available during the workshop.
