Fee	Associates contribute fully to the financing of TALIS in accordance with a cost sharing formula that has been established for OECD Members. Annual fees are composed of a floor contribution, determined by the TALIS Governing Board, plus a flexible component calculated on the basis of the OECD principles and rules for determining the scales of contributions by Members other than for Part I of the Budget of the Organisation, using as input statistics the national income data and exchange rates used in the calculation of scales for the previous year.
