PANEL: Strategic planning of infrastructure for building back better

The panel will provide an overview of the changes brought by the COVID-19 crisis to infrastructure plans. It will discuss how the future of infrastructure will look like from shifts in demand to developing a shared vision of long-term planning and rethinking distribution of risks. The panel will reflect on measures and initiatives taken by public institutions and by the private sector to shape infrastructure plans so they become integral to the recovery phase and contributes to a sustainable and inclusive growth.

- Among the many impacts of the crisis, what are those which put a new impetus on infrastructure-led recovery programmes?

- How to accelerate the identification and sharing of good practices throughout infrastructure programmes so the pace of infrastructure investments can be accelerated?
