The EU-funded project "Support to Enhanced Administrative and Public Economic Governance in Egypt" is implemented by the Organisation for Economic Co-operation and Development (OECD) for a period of five years (2022-2026). It aims to support the efforts by the Government of Egypt to strengthen the monitoring and implementation of priority public governance reforms. More specifically, the EU funded project addresses three priority areas through two components, namely support to the Egypt Vision 2030 and the National Administrative Reform Plan, as well as support to the effective and efficient execution of public finance systems. These objectives respond to the EU-Egypt Partnership Priorities 2021-2027 and will be implemented through the strategic collaboration between the Government of Egypt, the EU, and the OECD.

Objectives

As part of the project, the training: "Public Administration Reform – key Enablers and good practices in OECD Countries" on 7 – 8 June 2023 will aim to support public officials in CAOA in their efforts to spearhead the Public Administration Reform process in Egypt. It will strengthen the capacity of the key actors to implement these reforms by building their knowledge and skills on fundamental concepts, principles, processes, and models in line with OECD standards. The training will also provide an overview of the key drivers underpinning successful public administration reforms through good practices and case studies from OECD countries. Interactive discussions with peers will focus on deepening into different public administration reform areas, namely on public employment and strategic human resource management, publics service delivery and enabling regulatory reform.

This capacity building workshop is designed to support the updating process led by CAOA of the NARP as part of the training program on public administration reform and its subsequent on-site coaching activities. As key outcomes, the training will (a) **build knowledge and skills on Public Administration Reform** enablers, models and instruments; (b) **support CAOA** in the development of an action plan for the updating process of the NARP; and c) assist CAOA in creating a task force and adopting a whole-of-government approach for the implementation of the NARP.

The training will be held in English with Arabic interpretation available.

The session will present a methodological framework for Public Administration Reform baseline assessment and necessary action items for updating the NARP.

13.00-14.30 Session 3: Institutional arrangements and key functions underpinning public administration reforms in OECD countries

The session will provide an overview of different institutional frameworks (functions and competencies) for planning, coordinating, implementing and monitoring the Public Administration Reform efforts and its different components in OECD countries. It will define different actors involved and their role across the different areas of public administration reform, including on public employment, strategic human resource management and public service delivery.

The session will also reflect on the need for a coordinated approach for these reforms and expand on the inter-institutional relations (including steering coordination and reporting relations) and mechanisms existing among such public bodies. The session will also share tools and instruments for planning and coordinating public administration reform efforts in OECD countries.

Through working groups, attendees will be invited to discuss the key actors, functions and roles in the different phases (design, planning, coordination, implement assist CAOA in identifying the main actors involved in the NARP and form a task force to facilitate its whole-of-government implementation, and monitoring) of the Public Administration Reform in Egypt.
