Training: Strengthening whole-of-government strategic planning and decision-making for Egypt Vision 2030

The EU-funded project "**Support to Enhanced Administrative and Public Economic Governance in Egypt**" is implemented by the Organisation for Economic Co-operation and Development (OECD) for a period of five years (2022-2026). It aims to support the efforts by the Government of Egypt to strengthen the monitoring and implementation of priority public governance reforms. More specifically, the EU funded project addresses three priority areas through two components, namely support to the Egypt Vision 2030 and the National Administrative Reform Plan, as well as support to the effective and efficient execution of public finance systems. These objectives respond to the EU-Egypt Partnership Priorities 2021-2027 and will be implemented through the strategic collaboration between the Government of Egypt, the EU, and the OECD.

Objectives

As part of the project, the **training: "Strengthening whole-of-government strategic planning and decision-making for Egypt Vision 2030"** on **7** – **8** June 2023 will aim to strengthen capacities for relevant units in MPED to steer strategic planning reforms for Egypt Vision 2030 in line with the new planning law (18/2022) and state Budgeting law (6/2022). The first part of the training will present the existing models, tools and methodologies on key areas of the strategic planning process in OECD countries, with a focus on the institutional arrangements, processes, and instruments for strategic alignment and coordination. These concepts and models will be further expanded on through practical case studies from Portugal, Canada and other OECD countries. The second part will promote interactive discussions on strategic planning methods and tools for Egypt Vision 2030, opportunities for up-scaling existing efforts as well as the way forward. As key outcomes, the training will support MPED in identifying a number of tools/templates/manuals to be further developed to effectively assist the annual strategic investment planning process and Egypt Vision 2030.

9.00 – 10.30 Session 1: Strategic Planning frameworks, models and institutional set ups in OECD member and partner countries

This session will provide an overview of the different strategic planning models in the OECD countries to facilitate the coordination of this process across the whole-of-government. It will include an overview of how the strategic planning function is carried out to lead cross-cutting policy priorities or initiatives and coordinate across government.

The session will cover overview of models used to coordinate strategic objectives setting and prioritization with line-ministries. It will also look into how this process is aligned with broader national planning frameworks, how it is aligned with funding and budgeting, and how it supports and ensures implementation.

An introductory overview of the experiences of Portugal and Canada will follow. It will outline the key features of both cases with a focus on the key processes and tools used to effectively coordinate strategic planning and its linkage with budgetary priorities.

10.30-12.00 Session 2: Instruments, capabilities and mechanisms for steering and coordinating the whole-of-government strategic planning process

This session will focus on the needed institutional arrangements in government for coordinating the strategic planning process, including the coordination mechanisms and the instruments used in strategic planning in OECD member countries. These will mainly cover aspects regarding the collaboration with line ministries, the coordination and delivery of key strategic priorities and the alignment with the national planning broader framework(s) (such as vision 2030 in Egypt). It will also define the main institutional and individual competencies and capacities that are required in these institutions to perform the strategic planning role.

During the session, two peers will provide a reflection on the key functions and capacities that are mapped across the administrative bodies in Portugal and Canada in order to enable the various units in performing and carrying out strategic planning and budgeting processes.

Working groups will discuss mapping the key strategic planning capacities within Egyptian Administrative Units, along with identifying the key capacity building programs that can assist them in effectively conducting strategic planning.

Peers will provide a brief overview of mechanisms and tools that support the delivery of key government priorities in their country.

The session will cover working groups and discussions to define the number of tools that can assist the coordination of strategic planning process across the administrative units in Egypt.
