Objectives

As part of the strategic partnership between the Government of Egypt and the European Union (EU), the High-level conference of the "Support to Enhanced Administrative and Public Economic Governance in Egypt" project funded by the European Union, will take place on 8 – 9 February 2023 in Cairo. This five-year project implemented by the Organisation for Economic Co-operation and Development (OECD) aims to support the efforts by the Government of Egypt to strengthen the monitoring and implementation of priority public governance reforms. More specifically, the EU funded project addresses three priority areas, namely support to the Egypt Vision 2030 and the National Administrative Reform Plan (ARP), as well as support to the effective and efficient execution of robust public finance systems. These objectives respond to the EU-Egypt Partnership Priorities 2021-2027 and will be implemented through the strategic collaboration between the Government of Egypt, the EU, and the OECD.

This high-level conference will aim to foster discussions on how to promote an integrated approach for the implementation of priority public governance reforms in Egypt, including Egypt Vision 2030 and the Administrative Reform Plan. The conference will provide an opportunity to officially launch the call for applications of the Youth Policy Shapers Programme and kick-start activities of the OECD Public Governance Review of Egypt (PGR). This will include sessions to introduce the OECD PGR, its methodology and the way forward. The event will also gather public officials from various Egyptian government institutions to foster peer-to-peer discussions and the exchange of good practices with international experts through a series of technical workshops.

11.15 – 12.30 Session 1: Building a civil service that is fit for purpose

This session will reflect on the ongoing Public Administration Reform process in Egypt. The Central Agency for Organisation and Administration will present its efforts to modernise the civil service in the framework of the Administrative Reform Plan. The OECD and an expert will then share insights and international good practices on avenues to promote strategic management of human resources within the civil service, including with a gender-sensitive lens and youth perspectives. The session will finally open discussions with attendees on the opportunities ahead to equip the Egyptian civil service with the right tools and skills to face the current challenges of the 21st century.

12.30 – 13.45 Session 2: Delivering Vision 2030 through an integrated Public governance approach

This session will explore potential avenues to enhance the strategic role of Egypt Vision 2030 as the umbrella policy framework under which all governments' strategies are aligned to promote economic growth, social inclusion, and prosperity for future generations in Egypt. It will begin with a presentation by the Ministry of Planning and Economic Development on the existing mechanisms to lead the strategic planning and prioritisation process across government for the implementation of Egypt Vision 2030. It will be followed by a presentation by the OECD to share good practices and principles on how centre of government institutions can sustain whole-of-government coordination, promote multi-dimensional policy-making, and lead strategic planning and decision-making to deliver better outcomes for all, including women and youth. An expert will share practical examples and insights to illustrate these principles in practice before opening the floor for attendees to share their insights.

Ensuring all stakeholders, including youth, women and vulnerable groups, have a possibility to participate in the policy-making process is a cornerstone of good governance and a key component of sustainable reforms. By ensuring targeted, compelling and responsive public communication, using a variety of channels and messages, and based on audience insights, governments can ensure that the public is better informed and able to engage in a dialogue on issues that matter most to them. In parallel, promoting transparency and access to information also facilitates the ability of citizens to engage in an informed dialogue with the government and participate in decisions that affect their lives. The session will begin with a presentation by the OECD on transparency, access to information and the use of public communication for inclusive policy-making, better stakeholder engagement and sustainable reforms.
