6. WORKSHOP ON WOMEN AND AGRICULTURE, WITH A FOCUS ON LAND RIGHTS AND FOOD SECURITY

The recent financial, food and fuel crises have led to renewed attention by donors to agriculture, food security and rural development. Women are major players in agriculture, making up the majority of farmers and farm labourers in many countries. Women produce most of the food that is consumed locally and are responsible for household food security in many rural areas. More equitable access to land, fertilisers, water for irrigation, seeds, technology, tools, livestock and extension services would make agriculture a more efficient means of promoting shared economic growth, reducing poverty and improving food security and rural livelihoods.

Objectives:

The **overall objectives** of the workshop are to inform GENDERNET members so that they are better equipped to contribute to policy and programming discussions on agriculture with specialist colleagues, and to inspire innovation within their agencies, by:

- deepening knowledge and understanding of issues related to women's role in agriculture,
- identifying entry points for strengthening practice in both policy approaches and programming, and
- encouraging the free exchange of information and collaboration amongst GENDERNET members, agricultural specialists and other development actors.

The expected outcomes of the workshop are:

- fresh ideas for the GENDERNET's work programme, including identifying ways to deepen collaboration with UN Women and IANWGE and to contribute to OECD work on food security, and
- identification of opportunities to support women's economic empowerment through agriculture in the implementation of IDA16.

Case study 2: Participatory Action Research on Gender and Agriculture Innovations in Ethiopia (a JICA programme)

The project “Abdi Boru Community Development Initiative (ABCoDI): Hope of Tomorrow” was started in Ethiopia in 2008 with the support of JICA. Its objective is to improve the quality of life of the rural community and empower women through promotion and integration of both scientific and indigenous knowledge, by integrating the ‘KAIZEN’ (continuous improvement) approach for rural development in Japan.

Case study 3: Promoting Women’s Empowerment in Smallholder Horticulture Empowerment Project (SHEP) in Kenya (a JICA project)

The project “Small Holder Horticulture Empowerment Project in Kenya” supported small scale farmers to increase their income, by changing their priorities from “producing first and marketing second” to “making efforts to produce marketable and better quality crops”. The project addressed women’s role in farming and farm management, encouraging a changed relationship between men and women within the household from “one farm manager and one farm labourer” to an “equal farm management partner”. As a result, the average income of the small scale farmers was doubled.

Case study 4: Making value chains work for women and men – a video presentation introduced by IFAD

IFAD supported Oxfam Novib to pilot a community-led methodology for market/value chain development (VCD), which aims at pro-poor wealth creation and gender justice. The project took place in Uganda involving local organisations in the coffee, maize, beans and fruits value chains. The methodology has proven to be effective for pro-poor wealth creation and women's empowerment.
