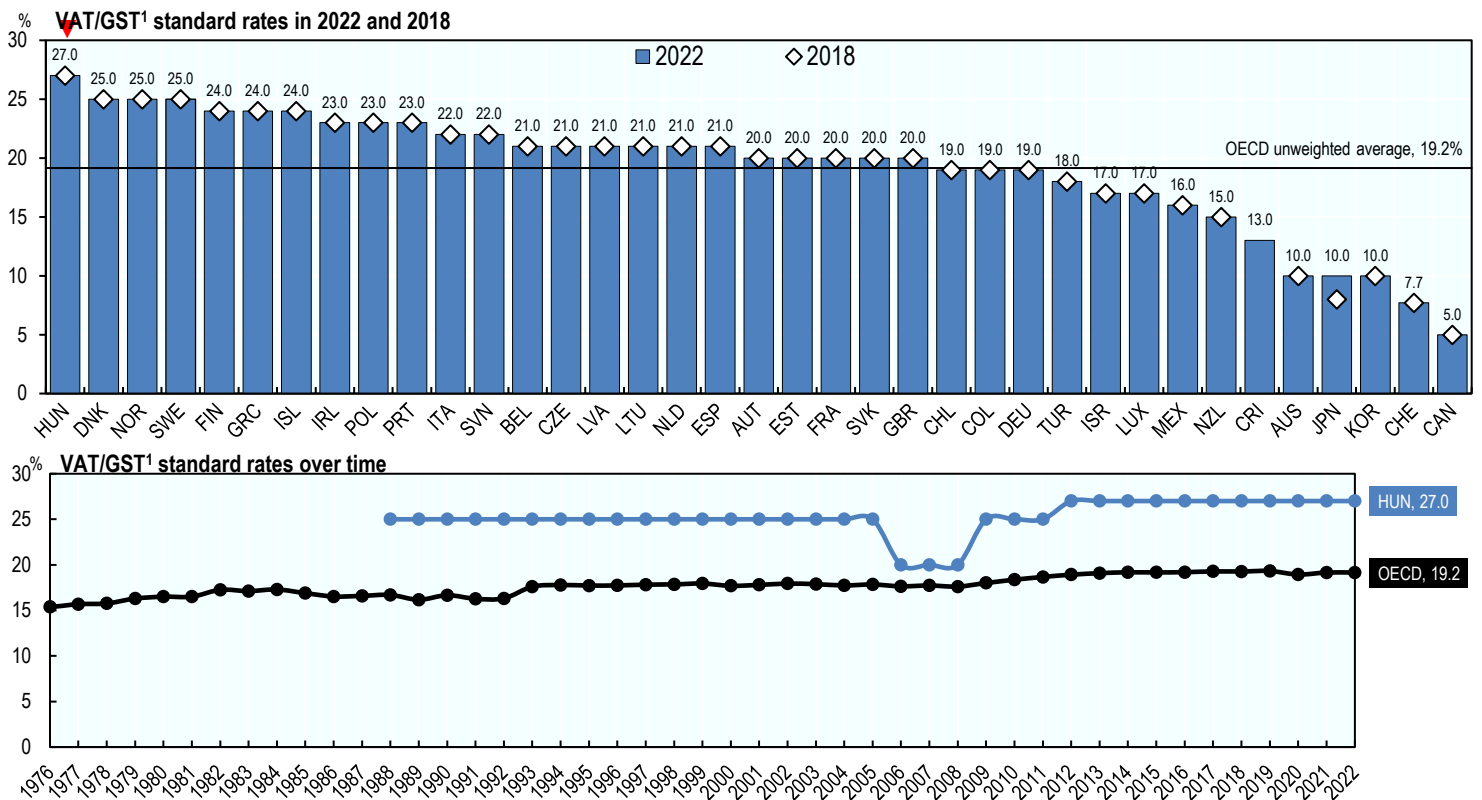


## Consumption Tax Trends\* - Hungary

### VAT rate 2022

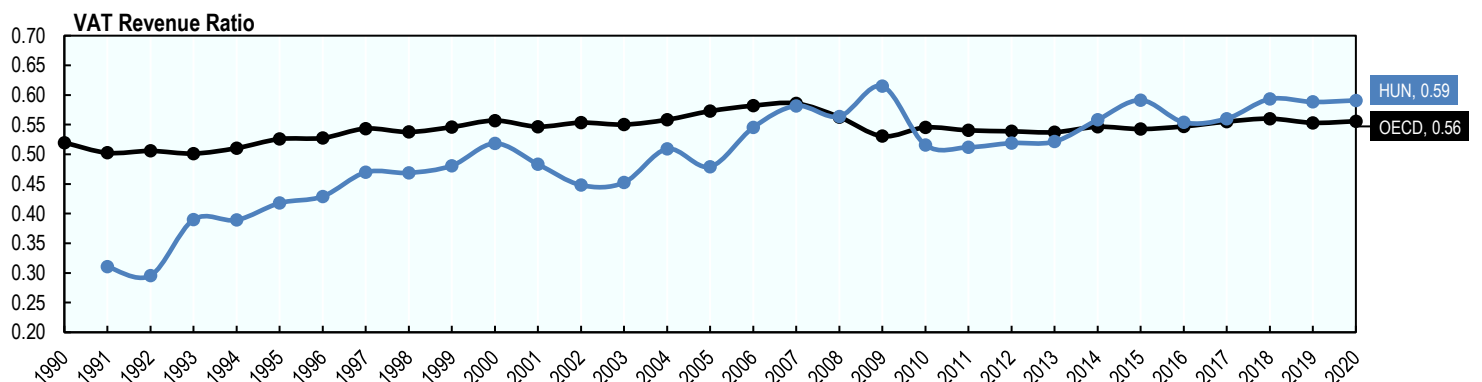
The Hungarian standard VAT rate is 27.0%, which is above the OECD average. The average VAT/GST<sup>1</sup> standard rate in the OECD was 19.2% as of 31 December 2022. The previous standard VAT rate in Hungary was 25% in 2011. It changed to the current level in 2012. Hungary applies reduced VAT rates of 5% and 18% to a number of goods and services. Temporary specific reduced VAT rates applied in the context of the Covid-19 pandemic until June 2022. VAT was introduced in Hungary in 1988 at a standard rate of 25.0%. Since then the minimum and maximum standard rates have been at 20.0% and 27.0% respectively.

### VAT Revenue Ratio

The VAT Revenue Ratio (VRR) for Hungary was 0.59 in 2020, above the OECD average of 0.56. The VRR is a measure of the revenue raising performance of a VAT system. A ratio of 1 would reflect a VAT system that applies a single VAT rate to a comprehensive base of all expenditure on goods and services consumed in an economy - with perfect enforcement of the tax. The Hungarian VRR remained stable at 0.59 between 2018 and 2020. The lowest VRR was recorded in the year 1992 at 0.30 and the highest level in 2009 at 0.61.

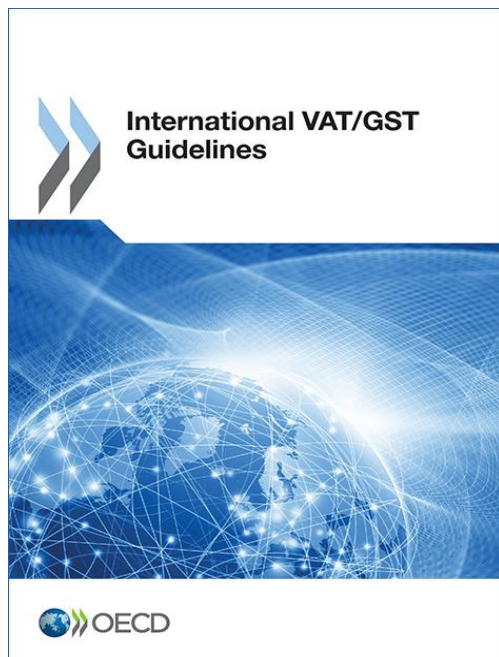

They notably include the recommended principles and mechanisms to address the challenges for the collection of VAT on cross-border sales of digital products that had been identified in the context of the OECD/G20 Project on Base and Erosion and Profit Shifting (the BEPS Project).
