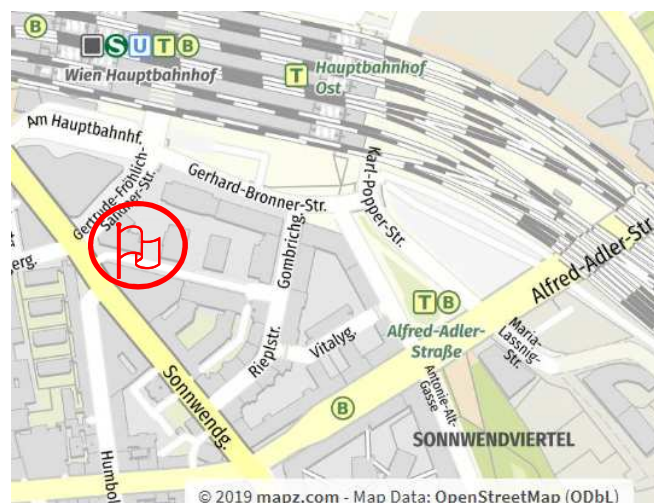

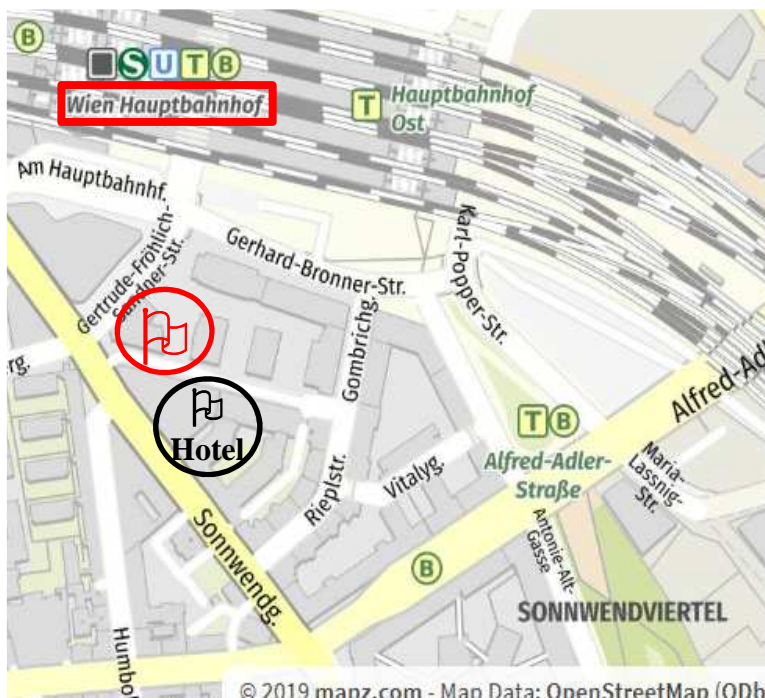

GETTING THERE



Train: Take the **Railjet** (15 minutes to Vienna Hauptbahnhof/main railway station) – Single ticket EUR 4.20 (one way).

Bus: Take the **Vienna Airport Line bus** to Vienna Hauptbahnhof – Single ticket EUR 8 (one way).

Taxi: It is possible to take a **taxi** from the airport directly to the Austrian Federal Academy of Finance. The taxi will cost approx. EUR 35.

Car: If you arrive **by car** make sure you do not park in front of the Academy as parking time is limited (90 minutes) and requires appropriate parking tickets. We recommend to use the hotel parking garage. Further information can be obtained at the Hotel Zeitgeist Vienna.

ACCOMODATION AND MEALS

All experts and event participants will be accommodated free of charge in the Hotel Zeitgeist Vienna (including the night before and the middle night). Explanation: Seminar from Monday to Friday = arrival on Sunday/Monday and departure on Friday or Saturday -> all these costs will be covered by the Academy.

Nights outside of this time are additional nights and will be charged to the experts/event participants.

Additional nights have to be paid directly by the expert/participant to the hotel. The costs are up to EUR 88/night/person depending on the category of single- or double-room. For booking of additional nights, please contact the Hotel Zeitgeist Vienna directly (booking@zeitgeist-vienna.com; booking code: OECD-BFA).

Accompanying person staying in your double-room cannot be covered by the organisation. In this case, an additional fee of EUR 15.00/person/night will be charged. Please be so kind to inform us before the arrival so that we may do the necessary arrangements for a double room.

The Hotel is connected to the Federal Academy of Finance – you will get a transfer card at the beginning of the seminar.

Meals (breakfast/lunch/dinner) **are not included!** Refreshments are served in the morning and during the breaks.

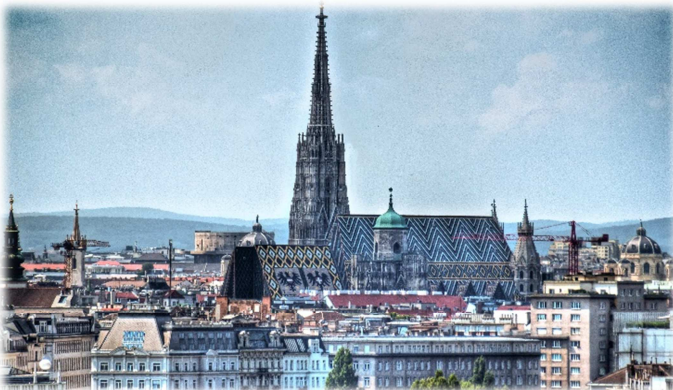


OFFICE FACILITIES AND SUPPORT STAFF

VISITING VIENNA

The next metro/underground station "Hauptbahnhof" **U1 red line** is near the Centre and it takes about ten minutes to reach the first district. Furthermore, you have the opportunity to take one of the "hop-on-hop-off"-busses to visit some beautiful places in Vienna (tickets approx. EUR 30 for one day trip).

Experts and participants are recommended to buy a weekly pass valid for a calendar week, valid from Monday to Monday on all means of public transport within Vienna. The cost of this ticket is approx. EUR 15.00 and can be purchased in any local tobacconist or metro station. A pass photo is not required.
